- 1.1 These rules may be cited as the Energy Bills Discount Scheme (Amendment No. 2) Rules 2024.
- 1.2 They come into force on the 22nd of March 2024.

## 2 Amendments

- 2.1 The Energy Bills Discount Scheme Rules 2023 are amended as follows.
- 2.2 In rule 16.4.1<sup>1</sup>:
- 2.2.1 in sub-paragraph (c), after paragraph (i), insert:
  - "(ia) in any other case relating to a QHS application, 10 days after the relevant decision date;";
- 2.2.2 for sub-paragraph (d), substitute:
  - "(d) for sending a notice of an interested person's views:
    - (i) in relation to a QHS application, 5 days after the date on which the review request was sent; or
    - (ii) in any other case, 15 days after the date on which the review request was sent.".
