Thanks for your email.

FCC Recycling (UK) Limited have chosen to exercise their rights to appeal the Environment Agency's decision. On 8 June 2023, Environment Agency made a request via the Planning Inspectorate to delay the start date for the appeal and to put the appeal process into abeyance for negotiations to take place between the Environment Agency and FCC Recycling (UK) Limited with the aim of working towards an agreed outcome and therefore to obviate the need for an appeal.

FCC Recycling (UK) Limited declined this request and consequently the appeal process commenced on 14 June 2023.
