IV. Health Information

- I, the undersigned, certify that the fresh poultry meat described overleaf meets the following requirements:
- a) the said poultry meat was derived from poultry which were slaughtered in the United Kingdom;
- b) the poultry from which the meat was derived was subjected to pre-slaughter health inspection and post-mortem inspection under official veterinary supervision and found fit for human consumption in accordance with Regulations currently in force in the United Kingdom;
- c) the poultry was slaughtered and the meat prepared in an UK approved establishment, and where no red meat was handled;
- d) the birds from which the poultry meat was derived did not originate from holdings in an area which is under restrictions due to an outbreak of Newcastle disease, Highly Pathogenic Avian Influenza or any other poultry diseases statutorily notifiable in the United Kingdom;
- e) the poultry meat was packaged in new and clean packaging and provisions are in place to prevent contamination of the packaging, in the United Kingdom;
- f) the poultry meat did not come into contact with any poultry meat which was not produced in accordance with UK requirements;
- g) the packaged poultry meat was stored separately from red meat in the cold room to prevent contamination of the packaging;
- h) the poultry meat is suitable for human and animal consumption in the United Kingdom;
- i) the container identified at paragraph $I\left(e\right)$ was thoroughly cleaned prior to loading.
