1 Introductions

- **1.2** It was noted that the meeting was not quorate and that any formal decisions would therefore be postponed or made by correspondence following the meeting.
- **1.3** CE left meeting to contact LD and bring forward the Misbourne Greenway agenda item

2 Review of Minutes & Action Tracker

- **2.1** The minutes and action tracker review will take place at next meeting when quorate.
- **2.2** It was noted that following discussion at the previous meeting in October, Review Group Members had approved the following points by correspondence, and the Chair had communicated them to the relevant parties:
- Fund option 1 of the Wendover towpath request: i.e. up to £380k (not the full £720k requested).
- Support the proposed reallocations of existing funding on the Ridgeway and Landscape & Biodiversity projects (maintaining existing budget for contingency purposes), and,
- Support, <u>in principle</u>, the Misbourne Greenway project, subject to agreement of funding details (discussed below).

3 EKFB Update

- **3.1** Programme Update. SA gave an update on key EKFB issues around programme and design. Update attached at Enclosure 3.
- **3.2** Discussion. Panel Members discussed the benefits of the video update

4 Misbourne Greenway proposal

- **4.1** LD gave briefing on the request for further funding for an extension of the Misbourne Greenway (see separate enclosure for further details). He responded to various queries relating to cost risks, expressing high confidence in the cost estimate and that the contingency allocation would be sufficient.
- **4.2** Programme and Design. LD gave an update on the programme and the design, explaining that necessary consents and designs were all but ready.

- **4.3** LD explained that they had secured £247k in match funding and requested an additional £330k from the review group for a 1km extension of the route. He confirmed that a positive decision by end January would enable the works to proceed.
- **4.4** LD offered a site visit to the panel.

4.4.1 LD Site Visit offer:

In terms of a possible site visit, Sustrans would like to invite members of the panel to see the route. Sections of it are almost complete while some are in construction. Panel members could also see the 1km unfunded section.

Suggest a site visit lasting approx. 2 hours, between Wendover and Great Missenden. Confirm logistics closer to the time, but it would likely require panel members to drive to site and then walk for a couple of kilometres as a group.
