Please visit the online payments service <u>GOV.UK Pay</u> link which will take you to MHRA Pay to pay the fee using either credit or debit card. We accept debit cards (DC) - Maestro; Delta; Visa Electron and credit cards (CC) – Mastercard, Visa and American Express.
