Representations received

 One received regarding the item 'To discuss the conversion of Blessed Sacrament RC Primary School, Islington - to join The Cardinal Hume Academies Trust, Westminster', which is a Converter Academy Order project.

This representation was shared in advance of the meeting with all attendees and considered alongside their corresponding item.

 AB members discussed regional and London LAs absence data for Autumn and Spring terms 2016/17 to 2022/23.

Local Update

 A brief overview of the Islington LA was provided, highlighting social contrasts across the borough, school attendance, and the challenges posed by demographic changes (surplus places).

Converter Academy Orders

Points discussed in relation to school conversion.

Project: To discuss the conversion of Blessed Sacrament RC Primary School, Islington - to join The Cardinal Hume Academies Trust, Westminster

AB discussion: Blessed Sacrament RC Primary School is a Voluntary Aided school with 76 pupils on roll (as of 11 January 2024) operating under the Diocese of Westminster. The school was rated 'Good' by Ofsted (October 2018).

Blessed Sacrament has applied to convert to academy status and join The Cardinal Hume Academies Trust (CHAT). CHAT is a secondary MAT with three secondary academy converter schools across three local authorities.

AB members noted that Islington was currently undertaking formal consultation on closing the school. AB considered representations from the LA, emphasising the challenges posed by surplus primary places in the area.

AB discussed the challenge of surplus places and Islington's plan to manage this issue.

AB discussed the financial challenges and academic outcomes of the school as well as the low pupil numbers.

AB members noted the Archdiocese of Westminster's desire to keep the Blessed Sacrament open, and their concern around the lack of faith-based provision in the area.

Given the contentious nature of the issues around the school's future, the Regional Director determined that the application should be escalated to the Minister for decision.

RD decision: N/A

Conflicts: Penny Barratt, CEO of The Bridge MAT, was not present for this item and did not receive the papers.

Further actions required: To be sent to ministers for final decision. Stakeholders will receive communication when a final decision has been taken.
