JUDGMENT ON REMEDY

The judgment of the Tribunal is that the RESPONDENT is ordered to pay the claimant the total amount of **£3,780,587.39**, as set out below, by no later than 4 April 2024.

Notes on this judgment:

1. The amounts enumerated at 1.1, 2.1, 2.2 and 5 have been agreed by the parties, based on the relevant findings made by the Tribunal.
2. The calculation for grossing up (6) has been made on the basis that the total sum to be grossed up for tax is £2,475,271.61 (as tax is not payable on £120,000 of the award). It comprises the following elements: (i) £12,567.50 (in respect of the first £50,270); (ii) £49,913.33 (in respect of the next £74,870); (iii) £1,922,834.95 (in respect of the remaining £2,350,131.61).
