Release of Information

Further to our interim correspondence of 5 November 2021, I am now in a position to provide you with a substantive response to your request for the following information:

'I would like to know the movements and activities of HMS Gloucester for the following dates if at all possible.

Feb-May 1997 Feb- November 2000 June 2005 - March 2006 November 08 - January 2009'

Your enquiry has been considered to be a request for information in accordance with the Freedom of Information Act 2000.

A search for the information has been completed within the Ministry of Defence and I can confirm that some information in scope of your request is held. The recorded information held on ship movements for HMS GLOUCESTER from February to November 2000, June 2005 to March 2006 and November 2008 to January 2009 can be found at Annex A to this letter.

Please be advised that no recorded information is held on ship movements for HMS GLOUCESTER for the specified time period February to May 1997.

If you have any queries regarding the content of this letter, please contact this office in the first instance.
