Release of Information

Further to our interim correspondence of 6 December 2021, I am now in a position to provide you with a substantive response to your request for the following information:

'I would like to know the movements and activities of HMS Nottingham for the following dates if at all possible.

January 1997 - September 1997

April 1998 - July 1998

July 2006 - December 2006'

Your enquiry has been considered to be a request for information in accordance with the Freedom of Information Act 2000.

A search for the information has been completed within the Ministry of Defence and I can confirm that some information in scope of your request is held. The recorded information held on ship movements for HMS NOTTINGHAM for the specified time periods can be found at Annex A to this letter.

Late March 1997 (no date): Assumption of duties as Fleet Ready Escort

Early April 1997 (no date): Alongside in Portsmouth for Easter Leave

Mid-April 1997: Sailed to conduct weapon training and a visit to Hull

28 April 1997: Sailed from Portsmouth for passage to Lisbon for Exercise Linked Seas May 1997: Period at Butec and training

June 1997: Assisted maintenance period alongside in Portsmouth

1 July 1997: Recovery training period at sea

1-14 July 1997: Deployment operational sea training in the South Coast Exercise Areas 14 July – 8 September 1997: Alongside in Portsmouth for summer leave, pre-deployment leave and maintenance

17-30 September 1997: Passage including Suez Canal transit, Djibouti, exercises with the FS Jean de Vienne in the Gulf of Aden
