EXPORT OF DOGS AND CATS FROM THE UNITED KINGDOM TO GRAND CAYMAN AND THE CAYMAN ISLANDS

NOTES FOR THE GUIDANCE FOR THE OFFICIAL VETERINARIAN AND EXPORTER

IMPORTANT

These notes provide guidance to Official Veterinarians (OV) and exporters. The Notes for Guidance (NFG) should have been issued to you together with the Export Health Certificate 2933EHC. The NFG should not be read as a standalone document but in conjunction with certificate 2933EHC. We strongly suggest that exporters obtain full details of the importing country's requirements from the veterinary authorities in the country concerned, or their representatives in the UK, in advance of each consignment.

1. SCOPE OF THE CERTIFICATE

Export Health Certificate 2933EHC may be used for the export of dogs and cats from the United Kingdom to Grand Cayman and the Cayman Islands.

2. CERTIFICATION BY AN OFFICIAL VETERINARIAN (OV)

This certificate may be signed by an Official Veterinarian appointed by the Department for Environment, Food and Rural Affairs (Defra), Scottish Government, Welsh Government, or an Authorised Veterinary Inspector (AVI) appointed by the Department of Agriculture, Environment and Rural Affairs, Northern Ireland (DAERA), who is an Official Veterinarian (OV) on the appropriate panel for export purposes, or who holds the appropriate Official Controls Qualification (Veterinary) (OCQ(V)) authorisation.

OVs should sign and stamp the certificate with the OV stamp in any colour **OTHER THAN BLACK**.

Certified Copy Requirements - England, Wales and Scotland

Guidance concerning return of certified copies of EHCs has changed and only specific certified copies are required to be returned to the APHA. Certifying OVs must return a certified copy of EHCs only for the following EHC types:

• if the exported commodity is cattle, pigs, sheep, goats or camelids;

• if the certificate was applied for manually and the application documents have been emailed to APHA and not applied for via the Exports Health Certificates Online (EHCO) system.

Certified copies should be emailed on the day of signature to the Centre for International Trade Carlisle (CITC) at the following address: certifiedcopies@apha.gov.uk.

For certificates that have been issued to the Certifying OV via the EHCO system, the Certifying OV must complete the certifier portal with the status of the certificate and the date of signature.

A copy of all EHCs and supporting documentation certified must be retained for two years.

Certifying OVs are not required to return certified copies of other EHCs issued, however CITC may request certified copies of EHCs and supporting documentation in order to complete Quality Assurance checks or if an issue arises with the consignment after certification.

DAERA Export Health Certificates: provision of certified copies

Authorised Private Veterinary Practitioners (aPVPs) certifying DAERA Export Certification On-Line (DECOL) produced EHCs must return a legible, scanned copy of the final EHC to the relevant DAERA Processing Office within 1 working day of signing.

Good quality photographic copies will be accepted by the Department where obtaining a scanned copy is not feasible - for example, where 'on site' certification is undertaken and scanning facilities are not available.

For record purposes, a copy of the final Export Health Certificate and associated Support documents should be retained by the aPVP for a period of 2 years from the date of certification.

The Department will carry out periodic audits of all aspects of export certification to ensure that a high standard of certification is being maintained.

3. **IMPORT PERMIT**

All dogs and cats entering the Cayman Islands must be accompanied by an **Import Permit** issued by the Cayman Islands Department of Agriculture. You **must** provide evidence that your dog or cat complies with all the import requirements before the Cayman Islands Import Authoritiy will issue an Import Permit. The application form is located within the contents of this document. All correspondence and **copies** of the application documents should be written legibly in English, and can be submitted for consideration up to six months in advance of travel (see section B8 for further details). 4. **IDENTIFICATION**

Each animal must first be permanently identified with a microchip transponder and a microchip implant certificate issued. Proof of the date of implant is required.

Microchips implanted as of 1st March 2019 must be 15 digit numerical Internationsal Standards Organisation (ISO) compliant. Identification using ISO compatible (10 or more alphanumerical character) microchips will be accepted only if implanted prior to 01 March 2019. The microchip number must be recorded on all documentation required for the importation of the dog or cat. Once implanted, the microchip must be scanned prior to completing each step of the importation process (e.g. prior to rabies vaccination, prior to rabies titre testing, at the time of health certificate examination prior to tick and tapeworm administration).

5. **CLINICAL EXAMINATION**

Paragraph III (a) refers. The examination should consist of visual inspection, supported as necessary by clinical examination, laboratory reports, and pathological examination of any animals in contact with the animals for export.

6. RABIES VACCINATION

Paragraph III (b) refers. After identification, a licensed veterinarian using an approved inactivated or recombinant vaccine must then vaccinate your dog or cat against rabies and issue a rabies vaccination certificate. If your veterinary clinic does not have a (rabies) vaccination certificate template, then the template provided in Appendix A should be used. Your dog or cat must be at least twelve (12) weeks old before the primary (first) rabies vaccine is given. Subsequent booster vaccinations must be administered in accordance with the World Small Animal Veterinary Association's (WSAVA) recommendations. Note that that following the initial vaccination or primary course of vaccination a booster vaccination must be given after 9 to 12 months and only after this can the interval for revaccination be extended to 2 or 3 years for those vaccine licensed for 2 or 3 yeary boosters. Please see the below appendix B Cayman Islands Guidelines for Rabies Vaccinations for Dogs and Cats. (adapted from the WSAVA vaccination guidelines for dogs and cats)

The microchip number must be recorded on the rabies vaccination certificate. Vaccination certificates without a microchip number will not be accepted. The rabies vaccination certificate must also contain the make, serial number, validity of the vaccination, and expiry date of the vaccine product used. If your dog or cat was vaccinated before being fitted with a microchip, it must be vaccinated again.

7. RABIES SEROLOGY

Paragraph III g) refers. A blood test must be taken after vaccination to confirm the presence of protective antibodies against rabies. The blood test, a Fluorescent Antibody Virus Neutralising Test (FAVN), must be carried out by a laboratory approved by the Cayman Islands Department of Agriculture for carrying out such a test at a minimum of 30 days after the most recent rabies vaccination. The test result must show a serum antibody level of at least 0.5 IU/ml and must bear the animal's microchip number. Test results bearing the wrong microchip number will not be accepted and a new test will have to be carried out. The approved laboratories in the UK are:

The dog or cat will be eligible for entry into the Cayman Islands based on the rabies risk status of the country/territory of origin. To continue to be eligible to enter the Cayman Islands without delay, the titre test must be repeated on/before the 12 month expiration date

Provided that the titre test result is within its 12-month validity, the following eligibility options will apply:

• For animals entering from 'no' rabies-risk territoriesimmediately eligible for entry following a successful titre test result

- For animals entering from 'low' rabies-risk' territories'eligible for entry after a minimum of 2 months following a successful titre test result
- For animals entering from 'high' rabies-risk' territorieseligible for entry after a minimum of 3 months following the blood draw which provided the successful titre test result

These conditions apply to specified countries or territories, each with their own category assignment based on rabies risk. The risk assignments have been made by the Cayman Island authorities based on the following criteria:

- 'No' rabies-risk: territories in which indigenous rabies is absent in terrestrial animals
- 'Low' rabies-risk: territories in which rabies is present in wild animals, but not in companion animals
- 'High' rabies-risk: territories in which rabies is present in both wild and companion animals, or territories for which there are no data to prove otherwise.

8. ROUTINE VACCINATIONS

Paragraph III d) refers. All current routine vaccinations must be recorded on the official health certificate. Failure to do so will result in a delay of the processing of the import permit.

Mandatory routine vaccinations for **dogs** include distemper, hepatitis, and parvovirus.

Mandatory routine vaccinations for **cats** include panleukopenia, herpesvirus, and calicivirus.

9. OWNER'S DECLARATION

Paragraphs III (g), (i) and (j). The signed declaration, or declarations, must accompany the animals for the full duration of the journey, and should be made available to the Cayman Islands authorities on arrival. OVs should keep copies of the declarations for record purposes.

Please note: Certain breeds of dogs or crosses of such breeds are not allowed to be imported into the Cayman Islands. Genetic material such as semen and embryos from these breeds is also not eligible for entry into the Cayman Islands. All applications for the importation of dogs into the Cayman Islands must be accompanied by a written declaration from the owner/agent of owner attesting that the dog to be imported does not belong to or is not crossed with one or more of the following breeds or type of dogs. In addition, the applicant must provide a colour photograph(s) of the dog at the time of application that shows the true likeness of the dog. These breeds include:

- Pit Bull Terrier and its breed types;
- Dogo Argentino and its breed types;
- Fila Brazileiro and its breed types;
- Japanese Tosa and its breed types; and
- any breed of dog or crossbreed of dog whose breeding lineage was for the primary purpose of dog fighting. *

10. TICK/TAPEWORM TREATMENT

Paragraphs III (e) and (f) refer. Within 14 days of the scheduled date of travel to the Cayman Islands your dog or cat must be treated for

tapeworms and ticks. The treatment must be recorded on the Official Veterinary Health Certificate.

- For tapeworms: a preparation containing praziquantel at a dose rate of 5mg/kg body weight or in the case of a heavy dog, at a dose rate not exceeding the manufacturer's recommendations.
- For ticks: a topical acaricidal preparation known to have systemic and residual action against ticks to be used according to the manufacturer's instructions. Approved product ingredients include fipronil, amitraz, pyrethrins, permethrins, and isoxazolines.

NOTE: The following products are NOT acceptable: Shampoos, collars, preparations that are licensed for control of fleas only (e.g. Program® Advantage®, Revolution® or Sentinel®).

11. NOTIFIABLE DISEASE CLEARANCE

Official Veterinarians may certify paragraph III (i) on behalf of the Department provided that written authority to do so has been obtained from the Animal and Plant Health Agency - Customer Service Centre (APHA - CSC) in Carlisle or DAERA in Belfast on form 618NDC.

12. TRANSPORTATION INSTRUCTIONS

All animals travelling to the Cayman Islands must do so by the most direct route possible. Animals travelling by air must be carried in an approved container, which meets standards set, by the International Air Transport Association (IATA).

The animals must travel as manifest cargo. All documents accompanying the animal must be affixed to the container.

13. WELFARE

Exporters and transporters must comply with all the legislation for the welfare of live animals during transport. The welfare conditions required during transport, are set out in Council Regulation EC No 1/2005 (as retained), implemented in England by The Welfare of Animals (Transport) (England) Order 2006, with parallel legislation in Scotland and Wales. If transported by air, animals should also be transported in accordance with International Air Transport Association (IATA) standards.
