Section 31 Grant Determination Letter on additional funding to deliver aspects of the Government's rough sleeping strategy [31/6593]

This Determination is made between:

- (1) The Secretary of State for Education and
- (2) The local authorities listed at Annex A

Purpose of the Grant

The purpose of this grant is to provide funding to the local authorities in England listed at Annex A, towards expenditure lawfully incurred or to be incurred by them.

This grant is intended to support delivery of the commitment set out in the Government's rough sleeping strategy, to provide intensive support to care leavers at highest risk of homelessness/rough sleeping.

Funding is being provided to allow LAs that were part of this programme in 2022-23 to sustain work they are already delivering by continuing to employ one or more specialist advisers who provide intensive support to care leavers at highest risk of homelessness/rough sleeping; and to promote join up between children's and housing services within local authorities.

A total of £2,825,690 grant funding will be allocated to 54 local authorities in 2023-24. Annex A includes the total amount of funding awarded to each local authority for 2023-24.

Funding for 50 local authorities in 2024-25 has also been provisionally approved by the department and is subject to final budgets being confirmed by way of a separate determination letter next year. Annex B includes the

indicative amount of funding awarded to each local authority for 2024-25, subject to final budgets being confirmed.

SUPPORT FOR CARE LEAVERS AT RISK OF ROUGH SLEEPING GRANT DETERMINATION 2023-24 [31/6593]

The Secretary of State for Education ("the Secretary of State"), in exercise of the powers conferred by section 31 of the Local Government Act 2003, makes the following determination:

Citation

1) This determination may be cited as the 'Support for care leavers at risk of rough sleeping' Determination 2023-24.

Purpose of the grant

2) The purpose of the grant is to provide support to local authorities in England towards expenditure lawfully incurred or to be incurred by them.

Determination

3) The Secretary of State determines the authorities to which grant is to be paid and the amount of grant to be paid; these are set out in Annex A.

Payment of Grant

4) The total grant to be paid to each authority is set out at Annex A. The grant will be paid in two instalments of as near equal value as possible, on 31 July 2023 and 31 January 2024.

Treasury consent

5) Before making this determination in relation to local authorities in England, the Secretary of State obtained the consent of the Treasury.
