JUDGMENT

- 5. The respondent must pay the claimant £8497.00 in total.

- 7. The claimant was dismissed by reason of redundancy and is entitled to a redundancy payment of £2200.00.
- 8. The respondent has failed to pay the claimant's holiday entitlement and must pay the claimant £585.00.
- 9. The respondent must pay the claimant £6,146.92 in total.

10. The respondent has made unauthorised deductions from the claimant's wages and must pay the claimant £5361.76 gross.

- 11. The claimant was dismissed by reason of redundancy and is entitled to a redundancy payment of £5640.00.
- 12. The respondent must pay the claimant £11,001.76 in total.

Mr Thomas Keast - 1403355/2023

- 13. The respondent has made unauthorised deductions from the claimant's wages and must pay the claimant £2835.00 gross.
- 14. The claimant was dismissed by reason of redundancy and is entitled to a redundancy payment of £1100.00.
- 15. The respondent has failed to pay the claimant's holiday entitlement and must pay the claimant £1216.00.
- 16. The respondent must pay the claimant £5,151.00 in total.

Mr Wayne Ford - 1403356/2023

- 17. The respondent has made unauthorised deductions from the claimant's wages and must pay the claimant £3795.00 gross.
- 18. The claimant was dismissed by reason of redundancy and is entitled to a redundancy payment of £967.50.
- 19. The respondent has failed to pay the claimant's holiday entitlement and must pay the claimant £1380.00.
- 20. The respondent must pay the claimant £ 6,142.50 in total.
