<u>FREEDOM OF INFORMATION ACT 2000: MINISTRY OF DEFENCE POLICE: REPORTS</u> OF HARASSMENT

We refer to your email dated 03 November 2023 to the Ministry of Defence Police (MDP), which we acknowledged on the 06 November 2023.

We are treating your email as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your email you requested the following information:

Please can you tell me how many reports of harassment (include all harassment offences) the police force has received in each year from 2015 - 2023.

Please include -

- the outcome of each report (cautioned, arrested, prosecuted, no further action etc)
- the offence, offence category, class and sub-class
- the age of the person reported to the force (an age banding is acceptable if there are identification concerns)
- the age of the person who made the report (an age banding is acceptable if there are identification concerns)
- the relationship between the reporter and the reportee (i.e. partner, parent etc)

A search for information has now been completed by the MDP and I can confirm that we do hold information in scope of your request.

Please can you tell me how many reports of harassment (include all harassment offences) the police force has received in each year from 2015 - 2023.

Please include -

• the outcome of each report (cautioned, arrested, prosecuted, no further action etc)

- the offence, offence category, class and sub-class
- the age of the person reported to the force (an age banding is acceptable if there are identification concerns)
- the age of the person who made the report (an age banding is acceptable if there are identification concerns)
- the relationship between the reporter and the reportee (i.e. partner, parent etc)

Information has been provided in the table at Annex A.

We have no information held in relation to class or sub-class.

The Ministry of Defence Police will not release information that could potentially identify an individual. Individual details fall entirely within the scope of the exemption provided for at Sections 40 (Personal Data). Section 40(2) of the FOI Act 2000 has been applied to the ages of those involved in each case, to protect personal information as governed by the Data Protection Act 2018. Section 40(2) requires the Department to conduct a balancing exercise, this exercise involves balancing the rights and interests of individuals against the legitimate interests in disclosure, this is not the same as carrying out the public interest test associated with certain exemptions in FOIA. The balancing exercise is carried out to decide whether the absolute exemption in section 40(2) is engaged. In particular, there is no assumption of disclosure in the legitimate interest test, as there is with qualified exemptions. The outcome of the balancing exercise lay in withholding the personal data identified for this request. Ages have been provided in bands of 10.

If you are dissatisfied with the handling of your request, or the content of this response, you can request an independent internal review by contacting the Information Rights Compliance team, Ground Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail CIO-FOI-IR@mod.gov.uk). Internal review requests should be made within 40 working days of the date of this response.

If you remain dissatisfied following an internal review, you may raise your complaint directly to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not normally investigate your case until the MOD internal review process has been completed.
