1.0 Consultation Public Register

1.1 Privacy Notice

When you click on the link to the Forestry Commission's Consultation Public Register, a splash screen will pop up with the Privacy Notice. Please read this and click OK to continue to the register or Cancel to return to the Public Registers' gov.uk webpage.

Privacy Notice

Before submitting any comments and personal information to the Public Register, you confirm that you have read and understand this Privacy Notice.

Your comments will, in most cases, be shared with the relevant applicant. Your personal information (name and contact details), if provided, will not be shared with the applicant. The case information page on the Public Register will tell you which body is responsible for the application within the field named 'Organisation'.

If you provide your contact details, the Forestry Commission or the delivery partner may contact you in connection with your comments. Your contact details will not be used for any other purpose and will not be passed to any other third parties. Any contact details associated with your comments will be retained while the application is being processed and until the licence or grant agreement period has been concluded and then securely deleted.

If you do not want the Forestry Commission or the woodland creation delivery partner to hold your contact details or to contact you in connection with your comments, then please do not provide your email address in the optional email address field.



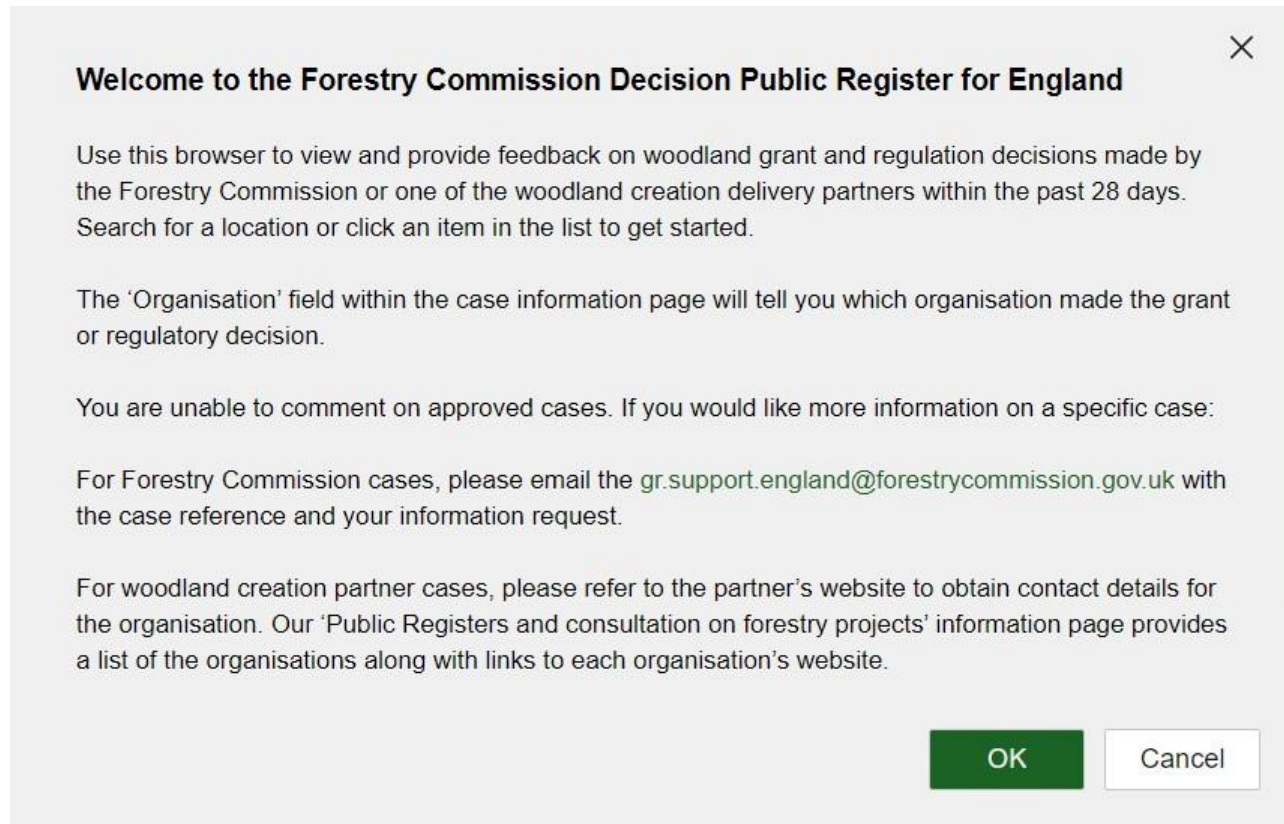
