<p>Statutory Provisions (Law)</p>	<p>Incorrect format of the statutory provisions have now been corrected to have the standardised format of the statutory provision.</p>	<p>Before: Incorrect format of statutory provision</p> <p>After: Correct format of the statutory provision applied</p>
<p>Missing and Invalid Spatial</p>	<p>Some few charges with missing and invalid spatial have now been amended</p>	<p>Before: Missing and Invalid Spatial on some charges</p> <p>After: Missing spatial now provided and invalid spatial now amended</p>
