Powers Exercised

1. The registrar of companies determines the fees set out below in exercise of the power conferred by section 1063(5) of the Companies Act $2006(\mathbf{a})$. The fees so determined are fees which apply in relation to functions, services and facilities for which fees are not provided for in regulations or, where such fees are provided for, in circumstances other than those to which such fees apply.

Introduction

2. The fees set out below apply to -

(1) the registration by the register of the documents provided for in Part 1,

(2) to any application to the registrar provided for in Part 2, and

(3) to any inspection of, or provision of copies of material recorded and kept by the registrar provided for in Part 3,

which takes place on or after 1 May 2024.

3. This Determination replaces the determination of 28 October 2022 which ceases to have effect.

4. Subject to paragraph 5, any words or expressions which are used in this document which are defined or otherwise explained in the Companies Act 2006 and, in particular, in Schedule 8 to that Act have the same meaning or explanation here as they have in the Act.
