




# Domestic Homicide Review guidelines

This booklet is from the UK Government.



We have a new set of guidelines about **Domestic Homicide Reviews** (DHRs).



A **Domestic Homicide Review (DHR)** is when different organisations look into when a person dies, or seems to have died, because of domestic abuse.



We want to know what you think of our new DHR guidelines.


Remember, a **coroner** is a professional who looks at a victim's body after they have died, to find out how they died.









