A search has now been completed within The Oil and Pipelines Agency (OPA) and I can confirm that some information in scope of your request is held.

In response to your request, I can advise that the OPA will be seeking to retender the contract for Occupational Health Services. In order to comply with the Public-Sector

Procurement (Public Contracts Regulations 2015), the OPA will publish tender opportunities on <u>https://opa.delta-esourcing.com</u> and the accompanying notices, including award notices for each contract, will be automatically published on the Government publication 'Contracts Finder'. Any information concerning the contract for Occupational Health Services, will be released to the public at the point of retender.
