### **Key NSE information:**

**Passports.** Ensure your passport is valid for a minimum of six months prior to any travel through Europe or UK/Overseas and within 10 years from date of issue. During your posting to Germany passports can be renewed in the NSE office. You will be required to provide up to date passport photos. Passport Application forms can be obtained in the NSE office and are to be returned completed to the NSE for onwards action. Passports for all eligible personnel will be paid for through the public purse, JPA Expense claims for photos are acceptable however please confirm entitlement with the NSE before paying.

SOFA ID / NATO ID Cards. A SOFA ID and NATO ID Cards cannot be obtained prior to your JPA Assignment Order date. Please submit SOFA applications for all accompanying personnel prior to arrival in Germany to avoid delays. If you are being assigned into a NATO position, your current unit must arrange your NATO security certificate for you. You must have a printed copy of this on arrival into Germany, failure to provide this could result in delays in the commencement of your assignment.

**Accommodation**. Your housing application (1132) should be submitted as soon as possible, please note that all housing is privately rented and is not available for those personnel in Long Term relationships. Consideration will be given to requests but housing is at a premium so choices may not always be available. Please do not proceed to Germany or book removals without being allocated an SFA/SLA by DIO.

**Removals**. The aim of Movement of personal effects is to enable service personnel and, where applicable, their accompanying dependants to move their personal effects at public expense within MOD limits. Respective application forms can be found at <a href="https://grms-external.agility.com">https://grms-external.agility.com</a>. Regardless of the type or size of property being moved into, the service person is limited to a cubic metre allowance based upon SLA/SFA to which the service person is normally entitled in accordance with housing regulations.

**Booking Travel.** No Travel should be booked until you have received an official '**CALL FORWARD**' from either the NSE (single/unaccompanied personnel) or DSCOM Families Section for those coming with family. Hotel accommodation may be required for those coming with families, approval for any German hotels should be obtained from the NSE by the losing unit prior to booking. You will be able to book your travel through your losing unit and GBT (used to be HRG).

If driving from the UK, you are entitled to Motor Mileage Allowance for up to two cars.

If you have not already done so, please ensure that you Register / Update your Details with Global Business Travel (used to be HRG). This will prevent delays with your booking for your move. Updating your details will also assist the Travel Cell whilst you are in post should you be required to attend courses or training during your time with us on UK business. #### **Status of Forces Agreement (SOFA)**

Please submit a SOFA application via the link in the pre-arrival's checklist on your proforma prior to arrival in Germany. This can be done up to **three months** prior to arrival.

You will require the following evidence for your application:

- Scan/image of passport(s)
- Passport style photo(s)
- Assignment Order
- Marriage Certificate.
- Birth Certificate.

The general legal status of non-German soldiers whose home country is a member of NATO is based on the NATO Status of Forces Agreement (NATO SOFA) rather than on European Union regulations and provisions. Under Articles III, IV, and V of the NATO SOFA, the following shall apply to soldiers of a NATO country stationed in another NATO country:

- The soldiers and their dependents shall be exempt from passport and visa regulations.
- The soldiers and their dependents shall be exempt from German regulations on the registration of residence.
- During their stay in Germany, the soldiers and their dependents shall not acquire any right to
  permanent residence or domicile in the territories of Germany within the meaning of the German
  Registration Act, or the German Driving License Ordinance (legal fiction under Article III, NATO
  SOFA).
- The right to residence in Germany is based on the NATO SOFA. The German laws on aliens shall not apply to NATO soldiers and their dependents.
- Soldiers shall only be required to produce their military ID card to identify themselves.
- Family members shall be identified as dependents of members of the force.
- The German Driving License Ordinance shall not apply to the soldiers and their dependents. In particular, Paragraphs 28 to 31 of the German Driving License Ordinance shall not apply since they are associated with the establishment of a domicile.
- The soldiers and their dependents shall not be required to acquire a German driving license. The
  Federal Republic of Germany shall accept as valid, without any reservation, the driving license
  issued by the sending State while members of a force are stationed in Germany (Article IV,
  NATO SOFA).
- The soldiers and their dependents shall not be exempt from German turnover tax (= value added tax);
- The soldiers and their dependents shall not be exempt from German income tax if they engage in any profitable enterprise in Germany (Article X, Paragraph 2, NATO SOFA)





# North Germany - Leave, Pay & Allowances

#### **NSE USEFUL INFORMATION**

Whilst assigned to Northern Germany there are several allowances available to support the additional costs incurred when relocating to and living in Germany. This guide will provide you with an understanding of what is available and what is required to receive these allowances. Whilst this guide provides you with the basic information on each allowance, you must ensure you are fully aware of the regulations related to that allowance, which can be found in JSP 752, prior to making any claim.

Overseas Private Vehicle Provision (OPVP)

OPVP is provided to assist Service Personnel permanently assigned to and from an overseas location with access to a private motor vehicle. The provision may be used in one of the following ways:

- 1. To contribute towards administrative and vehicle depreciation costs when selling and buying a vehicle. You must be able to demonstrate that two separate financial transactions have taken place.
- 2. To contribute towards the charges incurred (up to the capped rate) when required to cancel a vehicle lease agreement.
- 3. To contribute towards the cost (up to the capped rate) of privately shipping one vehicle to and from the permanent overseas assignment location.

### Disturbance Expense (DE)

DE contributes towards the necessary additional expenses that may arise when the Services require their personnel to make a qualifying move to or from a RWA on permanent assignment. This can be submitted up to 45 days prior to your move to and from Italy and is processed through JPA Self-Service. The rate of DE varies based on the location and accommodation type you are moving to and can be found within JSP 752.

#### **Relocation Leave**

When permanently assigned to an overseas location all personnel have an entitlement of 10 days relocation leave. This must be administered by the losing unit with the leave being taken prior to arriving at the new permanent duty station unless agreed otherwise with the gaining unit. Relocation leave must be taken within 6 months of the Assignment Order date. You should note that LOA is not payable whilst on relocation leave.

### Advance of Pay

On assignment to and from an overseas location, a Service Person may apply for an advance of pay up to four months' net pay which is repayable over 12 months. This can be applied for prior to assignment or on arrival at the new duty station.

#### **Local Overseas Allowance (LOA)**

LOA contributes to the necessary additional cost of day-to-day living when assigned overseas. It is a comparison of the cost of living in the UK v the cost of living in the overseas location. LOA is processed by the National Support Element (NSE) as part of your arrivals process and can be processed no earlier than 6 days before the Assignment Order date.

As part of the latest LOA review, an additional allowance was brought in to assist those accompanied personnel running 2 vehicles in location. It is called the 2nd vehicle allowance and is paid alongside your LOA. To receive this allowance, you must provide the NSE with a copy of vehicle registration and insurance documents for both vehicles. The documents must be provided following the registration/insurance renewal for each vehicle, annually.

### **Respite Provision (RP)**

RP contributes towards travel and accommodation costs for SP and accompanied family permanently assigned to an overseas station to achieve overnight respite from their duty station. This provision is awarded on an annual basis which is renewed on the anniversary of your Reporting for Duty Date (RDD). A full entitlement to the provision will still be awarded if you fall short of the entitlement anniversary.

### Get You Home (Overseas) (GYH(O))

GYH(O) is aimed at reducing the separation of eligible personnel from close family, friends and UK lifestyle that result from a permanent overseas assignment. This is achieved by assisting towards the costs of a return journey to the UK or, in the case of non-British passport holders, to the country of domicile.

This allowance is awarded on an annual basis which is renewed on the anniversary of your RDD. A full assignment year is required to be awarded this allowance. Any travel to and from the point of departure or final destination may be claimed on top of this amount up to the current MMA rates for that journey. Personnel may elect to drive back to the UK and claim their GYH(O); in this instance the claim will be capped at the current rate.

### **Leave Travel Days**

Whilst assigned to a GSO supported location, you will be entitled up to 3 days leave per leave year to compensate for the time taken to travel to and from the UK on leave. This is broken down into 3 periods of 1 days and to qualify for this you must have spent 2 working days on leave in the UK. This must be recorded correctly on JPA for audit purposes.

#### **Welcome to Germany**

This handbook is designed to give you as much advice, help and information as possible about the local area. Though by no means exhaustive, its intent is to help you prior to your arrival and during your time here in North Germany.

Your tour here in Germany will offer you lots of great opportunities with regards to travel, recreation and a whole lot more. The customs, culture and way of life here are significantly different from what you may be accustomed to and shopping, driving and dining are all a different experience. Some people may find this a little daunting at first but embracing the culture, food and people you meet will help ease the transition. We understand that moving yourself and your family to a new country can be extremely stressful, so our GSO staff are here to help you adjust and get settled.

### **Sponsorship**

Your line manager will allocate a sponsor to assist with your arrival. Your line-manager will try to allocate someone who lives nearby, whether married or single, and they will be able to show you the local amenities to help you settle in more quickly.

#### **Host Nation Liaison Officer**

We are lucky enough to have a Host Nation Liaison Officer (HNLO) who is available to do translations of documents you receive in German and will also translate English into German where necessary.

Learning the language or just the basics will go a long way. Guten Tag (good day), Morgen (morning) and Tschüss (bye) are handy words to know. It can be considered impolite not to say 'good day' or 'goodbye' when entering or leaving shops or establishments. Shaking hands is also seen as an expression of politeness.




# Goch - Welcome

Goch is a town in the <u>district of Kleve</u>, in <u>North Rhine-Westphalia</u>, <u>Germany</u>. It is situated close to the border with the Siebengewald in <u>Netherlands</u>, approx. 12 km (7 mi) south of <u>Kleve</u>, and 27 km (17 mi) southeast of <u>Nijmegen</u>. Goch is at least 750 years old: the earliest mention of Goch is in a document dated 1259. It was a part of the <u>Duchy of Cleves</u>. During <u>World War II</u>, the city was completely destroyed by Allied bombers during <u>Operation Veritable</u>. Since reconstruction after the war, Goch has developed into a pretty market town on the river Niers with between 30 and 35 thousand residents offering a wealth of history, culture and recreational activities.

### **Combined Air Operations Centre (CAOC)**

The Combined Air Operations Centre Uedem was activated in 1993 as part of NATO (North Atlantic Treaty Organisation). It is subordinated to Headquarters Allied Air Command Ramstein. CAOC Uedem is headquartered on the Paulsberg-Kaserne which is located 1 km from the town of Uedem and approximately 12km from Goch. The CAOC's main role is Air Policing of NATO's Northern Air Policing Area.






# Hamburg - Welcome

Hamburg, a major port city in northern Germany, is connected to the North Sea by the Elbe River. It's crossed by hundreds of canals, and also contains large areas of parkland. Near its core, Inner Alster lake is dotted with boats and surrounded by cafes. The city's central Jungfernstieg boulevard connects the Neustadt (new town) with the Altstadt (old town), and is home to landmarks such as the 18th-century St. Michael's Church. Hamburg is the second-largest city in Germany after Berlin.

#### FÜHRUNGSAKADEMIE DER BUNDESWEHR

The Führungsakademie der Bundeswehr (FüAkBw) / German Armed Forces Command and Staff College (GAFCSC)) is located in Blankenese, a suburb of Hamburg. The GAFCSC is broadly equivalent to the Joint Services Command and Staff College (JSCSC) Shrivenham. It consists of two separate barracks: the Clausewitz-Kaserne (CK) and the Generalleutnant-Graf-von-Baudissin-Kaserne (GBK). The Academy HQ is located in the CK, which is also where the Lehrgang General-/Admiralstabsdienst National (LGAN) and Lehrgang General-/Admiralstabsdienst International (LGAI) courses are delivered, i.e. the German equivalents of the Advanced Command and Staff Course (ACSC). British students attend the LGAN.





# Munster - Welcome

#### Münster

Münster is in the northern part of the state and is considered to be the cultural centre of the Westphalia region. It is also capital of the local government region Münsterland. Münster was the location of the Anabaptist rebellion during the Protestant Reformation and the site of the signing of the Treaty of Westphalia ending the Thirty Years' War in 1648. Today it is known as the bicycle capital of Germany. Münster gained the status of a Großstadt (major city) with more than 100,000 inhabitants in 1915. As of 2014, there are 300,000 people living in the city, with about 61,500 students.

Münster's Central Station is on the Wanne-Eickel–Hamburg railway. The city is connected by Intercity trains to many other major cities in Germany.

### Headquarters 1 (German/Netherlands) Corps

1 (German/Netherlands) Corps in Münster is one of NATO's High Readiness Forces Headquarters. We are capable of directing any mission of up to 60,000 troops at short notice – flexible forces including land, sea and air elements ready to move quickly to wherever needed. Multinational cooperation is an inherent part of our DNA. Germany and the Netherlands are our framework nations, but ten other NATO allies contribute personnel. This is why our motto is "Communitate Valemus" -Together Strong!







# Rostock - Welcome

The Hanseatic city of Rostock is famous for the Hanse Sail. Rostock is the largest city in Mecklenburg-Western Pomerania with around 200,000 inhabitants. At the same time, the city on the Warnow River is one of the most important port cities in the Baltic Sea region: numerous ferries and cruise ships regularly call at the Rostock port. Basically, the people in Rostock accept new residents very quickly. It is good to adapt to the customs a little and to use the greeting "Moin", which is traditional in northern Germany and especially on the coast, throughout the day. A simple Guten Tag (good day) or Morgen (morning) will go a long way. It can be considered impolite not to say 'good day' or 'goodbye' when entering or leaving shops or establishments. Shaking hands is also seen as an expression of politeness.

German Maritime Forces (DEU MARFOR) and Laage Fliegerhorst German Maritime Forces, or in the NATO abbreviation simply DEU MARFOR, is a military command or task force. Its staff plans, supports and conducts multinational maritime manoeuvres and operations. In times of crisis, for example, NATO or the EU can activate the staff as a maritime headquarters to command multinational naval units. Taktisches Luftwaffengeschwader 73 "Steinhoff" is responsible for the training of Eurofighter pilots and groundcrew for the German Air Force (Luftwaffe). It is based at Laage Fliegerhorst, shares the runway with the civilian Rostock airport and is approximately 20 miles South of the city. As well as its primary training role, the squadron supports Quick Reaction Alert (QRA) duties and provides aircraft and personnel to support operations






# Wesel - Welcome

Wesel is a city in North Rhine-Westphalia, Germany. It lies along the Rhine and Lippe rivers and the Lippe-Seiten Canal, northwest of the Ruhr. Because of its location near the rivers Rhine and Lippe, Wesel gained significance for its trade with the Netherlands and Westphalia and became almost as important as Cologne. Its location was also the reason why Wesel was destroyed almost completely during the Second World War. Wesel is located approximately 43.2Km from Düsseldorf Airport. In and around the local area you will hear the phrase Tschüss (bye) this is a local phrase from the surrounding area. A simple Guten Tag (good day) or Morgen (morning) will go a long way. It can be considered impolite not to say 'good day' or 'goodbye' when entering or leaving shops or establishments. Shaking hands is also seen as an expression of politeness. Schill Kaserne The Schill barracks is a barracks for NATO units in Wesel . It is named after Ferdinand von Schill (1776-1809). From 1965 it housed the rocket artillery battalion 150 and other units of the Bundeswehr. Schill barracks is located 6.6kms from the MQ's

#### **EDUCATION**

#### **Polite Notice**

The German system can be very different to what you are used to when it comes to finding a Nursery (Kindergarten) or Childminder (Tagesmutter). You may be looking at a wait time of up to 1 year to get your child a place in Kindergarten, so it is recommended as soon as you arrive to register your child. Places are normally allocated every August, if you are arriving in the first half of the year you might have to wait until the following year for a place. The Kindergartens are cheaper than the UK and charges are linked to annual salary. Before you arrive in post, if you have any children of preschool age, it is recommended that you contact the NSE in the first instance. We can then offer support if needed.

### Kindergarten

North Germany has an abundance of kindergartens. To register you will need an address your german address, not a BFPO address. Kindergartens are a popular option in Germany and there can often be long waiting lists. To register please use the link below.

The primary language taught in the kindergartens is German. Kindergartens are on a par with UK nurseries, learning through play and developing social skills. A great way for your little person to learn a second language too. Children can stay in kindergarten until the age of 6 years. The next stage would be primary school. The closest primary school is Liebfrauenschule, a 5-minute walk from Wisseler Str.

Authority needs to be obtained from SHAPE to use schools.

Schooling for dependants of UK personnel in the local area is limited and will require transport to either travel across the border into the Netherlands and up to Arnhem, or southwest into Germany towards Duisburg/Dusseldorf. Both journeys take approximately 45-60 minutes, traffic dependent, with no bus/taxi service in place to support UK school children or their families. Although there are other options in terms of considering boarding in Germany or back in the UK.

#### **School Fees/Administration**

### **Banking**

When you arrive in Germany, you will need a German bank account, which part or all of your salary can be paid into, and so you can make some direct debit arrangements for everyday bills. You have the option to split your pay into your UK and German account, the percentage of split is individual choice, and this can be actioned in the NSE office. Report to the NSE office once your German bank account is opened and complete a JPA E016b. You will need a German bank account if you want to set up a contract for telephone or internet services and reimbursement of NATO business T&S and mileage. Also, a lot of businesses in Germany do not accept the Visa debit cards. Restaurants, cafes etc. generally only accept EC cards (or cash).

Opening an account is very straightforward. All that is required is your national insurance number, passport and a letter of residency which can be issued by the HNLO.

There are banking affiliations within the German banking sector. If you withdraw money from a Geldomat (cashpoint) which isn't affiliated to your bank you will incur charges. Deutsche Bank is affiliated with the Post Office so you will not incur extra charges using a Deutsche bank card at the Post office. It is useful for you to bring Euros with you as getting your card and pin number could take a week or two. As mentioned, German businesses may not accept your UK credit cards.

### **General Accounting Rate (GAR)**

The GAR is the rate at which sterling is converted to the local currency by the military.

#### **UK Credit & Debit Cards**

It is possible to withdraw cash, with a UK credit/debit card, from a large network of cash point machines but a charge may be applied.

### Legal Help

### **HEALTHCARE INFORMATION - OUTLINE**

Please also read the Central European Practice Patient Information Leaflet which contains important and relevant information for all CEP locations – Each family member is to have a GHIC prior to moving to Germany.

Your healthcare during this assignment will be delivered by Host Nation providers, with secondary care coordinated by Healix in conjunction with the Central European Practice. You may also be referred into NHS services where appropriate.

This leaflet is designed to add local detail which may be useful as you arrive. If you are newly assigned you should also receive a panel list of known healthcare providers from Healix. Both Healix, your NSE and the CEP staff will able to support you in navigating the local healthcare system.

In the background the Central European Practice manages your NHS registration and records if you are fully registered. The CEP also conducts military occupational health clinics and can provide UK MoD clinical advice and support for our patients and to Healix.

#### **CEP TELEMEDICINE SUPPORT**

You can reach the CEP on telephone or email. If you wish to discuss a local healthcare pathway, military occupational medicine, submit your bills or send the CEP a secure and confidential message both eConsult and video-consulting are also available.

Before use it is essential to highlight that the CEP is not set up to provide direct care as we have no referral or investigation rights in your location so this is not a replacement for your host nation providers.

### **Prescriptions**

If you receive a prescription you can take it to the nearest Apotheke. You will have to pay for your medication and reclaim the cost, so please remember to keep your receipt as this along with a FIN07 is required to be submitted to CEP prior to reclaiming costs on JPA.

If you are prescribed medication for the first time, the Apotheek is only permitted to issue you with a 15 day supply. Most medication can be supplied for up to 3 months. Personnel who are not exempt from prescription charges, will be required to pay for the initial issue, but not for the supply over the 15 day period.

Info: 'Apotheke' is German for Chemist please look out for the sign below to find your local Apotheke. Please follow your Apotheke's guidance regarding ordering repeat prescriptions.

#### **Immunisations**

You should maintain a red book and be aware on assignment of when your child is due any immunisations.

Notably, children attending German Kindergarten or schools must have had chickenpox after the age of one or have the Varicella (chickenpox) vaccination. The measles vaccination is also mandatory for all children attending German Kindergarten or schools. Please ensure that your child's red health book is kept current with all vaccinations and assessments.

### **Other Child-Focused Organisations**

Health professionals will record your progress in a maternity record. In Germany this is called a Mutterpass. You will be given your Mutterpass and be asked to bring it to each medical appointment, the record will be updated by the Service Provider during your pregnancy. It is important to take your maternity record (Mutterpass) if you go to the UK (or other countries) so if you visit the midwife, hospital or GP whilst you are there, they can access previous information and record their findings.

### **Cervical screening**

If you are due to have cervical cytology, please book your appointment with the local clinic or Healix can help you to arrange it in the UK. UK screening is preferred but you may elect to have screening at post.

It is important, if electing to have your cervical screening in Germany, that you recognise that although the service is of good quality, the continuity of information is less coherent that continuing with UK screening. If you would prefer to have cervical screening in the UK, ideally linked to a trip you are making anyway, this may be organised through Healix or DPHC.

The CEP should be forwarded any results in order the basics may be entered on the national screening system.

### Physiotherapy and Rehabilitation

Once you have received a referral for physiotherapy from the Host nation GP, Healix should be informed and will provide you with a note of authorisation or link you to the providers with whom they have an invoicing relationship so that you can proceed with treatment. Please ensure you have obtained an authorisation letter prior to commencing physiotherapy treatment so that you do not become liable for the bill.

Healix will review the indication for therapy and then sessions will be authorised. Typically this will be reviewed after five sessions when a report from the treating therapist is required to authorise further sessions. The CEP will also be involved if there is any concern about a lack of progression or occupational implications for military personnel.

For military personnel, occupational health is a factor and commonly the CEP will offer a UK regional rehabilitation Unit referral and involve a GP to ensure the serviceperson is appropriately graded.

#### **Occupational Health**

Regular clinics will be conducted virtually and face to face review may be arranged if necessary.

Preparedness for military employment, deployment and routine medicals, including aircrew and other specialist medicals, is managed between the chain of command and the CEP.

Audiometry will also continue. Immunisation status is now available to commanders and individuals for the operational immunisations but the CEP will also review readiness for role and highlight deficiencies where possible.



# Health – Secondary care

#### SECONDARY CARE

### Referrals to Hospital / outpatient clinics

Should a GP refer you to another clinician, please make sure you let Healix know as soon as possible.

All referrals require approval prior to arranging an appointment at the hospital. This is partly to allow you to obtain a UK perspective on the treatment plan and also to ensure that billing is organised with the provider. Once approved, Healix will contact you to send you a guarantee of payment letter.

If your hospital clinician recommends surgery or any other significant intervention, you should contact Healix following the appointment to ensure the plan is authorised, safe, coherent with UK NHS standards. They will support you in arrangements and payment.

Please send any reports or invoices relating to approved hospital care directly to Healix.

#### Consultant Advisors and Clinical Review

If a specialist recommends surgery or other significant treatment which may have an impact on your operational fitness, Defence Consultant Advisor (DCA) opinion may be sought. DCAs are military clinical specialists who provide decision support in terms of ensuring treatment is in line with UK best practice and also advising on any impact on occupational fitness.

Should the DCA decide that your long-term career prospects may be best served by a different approach, a referral to a UK-based team may be recommended.

The CEP runs multi-disciplinary team meetings weekly between the doctors, medics, nurses and, if required, UK physio or health visitor. This allows management to be discussed as necessary between an experienced team. We recognise it can be challenging to have care overseas in a different language and culture. The aim is always to ensure that your treatment is safe, effective and in line with NHS standards.

## **Pets & Registering Dogs**

If you intend to bring your pet to Germany, you must include the details on your housing application form (Form 1132). You will be given guidance on the German Law regarding the keeping of pets and in respect of certain breeds that are banned in Germany.

You can no longer use a pet passport issued in Great Britain (England, Wales and Scotland) for travel to an EU country or Northern Ireland. You can still use a pet passport issued in an EU country or Northern Ireland. When travelling to an EU country or Northern Ireland, your pet needs:

- •a microchip
- •a valid rabies vaccination
- •an animal health certificate unless you have a pet passport issued in an EU country or Northern Ireland
- •<u>tapeworm treatment</u> for dogs if you're travelling directly to Finland, Ireland, Northern Ireland, Norway or <u>Malta</u>

These requirements also apply to assistance dogs.

## Repeat trips to an EU country or Northern Ireland

Your pet will need a new <u>animal health certificate</u> for each trip to an EU country or Northern Ireland.

Your pet will not need a repeat <u>rabies vaccination</u> so long as it's rabies vaccinations are up to date.

You can enter or return to Great Britain with your pet cat, dog or ferret if it:

- has been microchipped
- •has a pet passport or health certificate
- •has been <u>vaccinated against rabies</u> it will also need a blood test if you're travelling from an <u>country that is</u> not 'listed'

Dogs must also usually have a tapeworm treatment.

Your pet may be <u>put into quarantine</u> for up to 4 months if you do not follow these rules - or refused entry if you travelled by sea. You're responsible for any fees or charges

Once you are living in Europe your UK issued pet passports can be exchanged for an EU pet passport for a fee by your local vet.

Check the rules of the country you're travelling to for any additional restrictions or requirements before you travel

## **Driving In Germany**

If you wish to drive in Germany you must carry a valid driving license, insurance and vehicle documents with you in the vehicle at all times. You are also expected to carry a first aid kit, red warning triangle and a hi-vis vest for each occupant of the vehicle. If the vehicle does not belong to the driver, written permission from the registered owner may also be requested. The minimum age for driving a car in Germany is 18. The European Highway Code training and testing programme (also known as the Matrix Test) is for those stationed in Germany who are entitled to drive in Europe. It is designed to help military personnel, civilian staff and family members to understand the differences in signage, rules and regulations when driving in Germany and to a lesser degree driving in Belgium, Holland and France.

## **Vehicle Registration & De-Registration**

The GEO car registration & de-registration process may at first glance appear complex, but the process is relatively straightforward and the GEO admin assistant in the GSO N Germany NSE in Goch is ready to assist you through the process. <u>PLEASE</u> contact DVLA if you own a personalised number plate prior to arriving in Germany, as it will have to be put onto retention. All V5s must not have a personlised number detailed on the form prior to arrival in Germany,.

#### **Aral Fuel Card**

On receipt of the notification of registered number plate you will be able to logon to GEO homepage via bfgnet.de to register for your Aral fuel card, which will enable you to purchase tax free fuel at participating Aral garages. The card will be car specific and will include the car registration and your name and that of your partner (as required). The fuel card can only be used in Germany at participating garages. The cost of the card is €50. It has been estimated that even for a small car you will only need to refill twice before the card has in effect paid for itself.

#### Car Insurance

On arrival, in order to register your vehicle, you are to provide proof of insurance (GEO recognized). All insurance documents must have either a BFPO address if using a UK based insurer or a SFA address if using a German insurer, as all insurance must be valid for residency in Germany. You may find that your insurance premium will be significantly higher compared to your UK insurance.

### Car seats in Germany

Children must be at least 12 years old or 150 cm tall to sit in the front seat and/or use a regular seatbelt. Children under the age of 12 or 150 cm, must use an approved child seat

## Parking in Germany

The German disc – die Parkscheibe – allows you free parking for a certain time in areas displaying this sign.



## Winter (All-Season) Tyres

From the 1 January 2018, new regulation related to winter tyres (inclusive of all-season tyres fitted during winter months) has come into force in Germany. Previously regulations allowed for winter tyres to be marked with either a snowflake symbol or the Mud & Snow (M&S) symbol. As of 1 Jan 18, winter tyres produced for sale and use in Germany must be marked with the Alpine symbol also known as the Three Peak Mountain Snowflake (3PMSF) symbol. This symbol determines that the tyre is produced in line with new quality standards of winter tyres. An example illustration of the Alpine symbol is provided below.



There is no set period for the fitment if winter tyres to vehicles; however, it is recommended winter tyres should be fitted to vehicles between the period of October – April. Winter tyres do not negate the need to have snow-chains fitted when compulsory.

Failing to have appropriate winter tyres fitted; when road traffic conditions dictate may result in a fine, a road traffic offence being registered against the vehicle driver and even affect the integrity of vehicle insurance.

## **Drink Driving**

The legal alcohol limit is zero for beginners (less than two years' experience or under the age of 21), professional drivers, bus drivers, truck drivers, and drivers transporting passengers commercially; 0.03% in conjunction with any other traffic offense or accident; 0.05% otherwise.

For cyclists, the limit is set at 0.16%, where not in conjunction with any other traffic offense or accident, cyclists face the same penalties as driving a car at that limit.

**General Speed limits in Germany** are set by the federal government.

All limits are multiples of 10km/h. There are two default speed limits: 50km/h (31mph) inside built-up areas and 100km/h (62mph) outside built-up areas.

The default speed limits in the **Netherlands** are 50 km/h (31 mph) inside built-up areas, 80 km/h (50 mph) outside built-up areas, 100 km/h (62 mph) on expressways (autowegen), and, as of March 16, 2020, 100 km/h from 6:00 to 19:00 and 130 km/h from 19:00 to 6:00 on motorways (autosnelwegen).

## **Cycling in Germany**

Riding your bike in Germany requires you to have a road worthy bike with lights, reflectors, brakes and a bell to alert pedestrians that you are coming.

Cycling is very popular here in Germany and the Netherlands. There are dedicated cycle lanes, either for sole use by the cyclist or the pavement is divided for the pedestrian and the cyclist. Cyclists often use their bell to warn you of their presence. It is advised when walking to keep out of the cycle lane. Remember to cycle in the direction of the traffic, cycling the wrong way can result in a fine. Getting caught cycling whilst under the influence of alcohol can result in the German authorities confiscating your driving license.

### **Traffic Accident Guide**

Stay Calm, Keep Safe: If you are in accident, it's important not to panic. Turn off your car engine. Turn on your hazard lights and get out of the car safely - exit from the driver side to avoid traffic (RHD vehicles).

Exit the Car Safely: Wear a reflective vest, secure the areas and place the warning triangle. Take all necessary measures to avoid further damage or casualties. This includes extinguishing a fire if necessary.

Don't Put Yourself in Danger: Use a torch at night. Keep a safe distance away from your car and away from the road or highway. Don't smoke or use mobile phones if there is a risk of petrol fumes in the air. Don't move any vehicle until the police have arrived, unless there is a chance of further injury if it stays in place.

Call for Help: The safety of everyone involved is always the priority. If you or anyone else has been hurt in the accident, call the emergency services immediately on 110. Be prepared to provide personal details, information concerning the type of accident, your location and casualties.

First Aid: Any person involved in an accident is obliged to aid casualties. • Provide first aid if you have sufficient knowledge • Actively assist casualties and seek help.

Take Down the Details: Once everyone involved is safe or being cared for, it's time to annotate exactly what happened. You will need to write down: • The date, time and exact location of the accident • The name, address and phone numbers of the other drivers • The make, model and registration numbers of any witness(es), including passengers • Details of injuries and attending police officers • The insurance details of the other drivers Take photos of the accident with your smartphone, showing the positions of the vehicles involved, and any skid marks and damage. If you do not have a camera on you, ask others in the surrounding area for one or draw a sketch of the scene. \*The details mentioned are included in the standardised European Traffic Accident Report forms.

Don't Admit Liability: Whether you've had a minor prang or suffered something more serious, do not admit liability. Even if you think the accident was your fault, you shouldn't discuss details of an opinion with the other driver(s) without speaking with your insurance company.

Your Legal Responsibilities: Following a minor accident, it's possible to simply arrange a "Gentlemen's Agreement". This agreement can be settled if there were no injuries and no damage to public property (like road signs) as a result of the accident. In order to obtain all information required, you should use the standardised European Traffic Accident Report form.

Please Note: Ensure the safety and emergency equipment in your vehicle is up to date and in good condition. This applies especially for the First Aid Kit and the Fire Extinguisher. This equipment must be maintained frequently.

## **Personal Security**

Uniform and other branded clothing must not be worn in public, or whilst travelling. This includes during transit to, or through, the Channel ports. Wearing anything that could possibly be affiliated to the military, and all evidence of MOD links on the vehicles, must be avoided.

Do not advertise you are British or British Military and when out and about keep your personal belongings safe and out of reach of wandering hands.

When transiting around try and stay within well-lit areas and where possible avoid walking alone. Consider informing whoever you are visiting that you are on your way and the route you are taking. Also consider informing someone where you are going and how long you expect to be.

At all times remain vigilant, do not get involved in local disputes and always follow the advice of Security Professionals. If you see anything suspicious or out of the ordinary report it. Any information is good information.

Anyone can be at risk. Contrary to popular belief men are more likely to be assaulted on their way home than women.

Trust your instincts – if something doesn't feel right let someone know.

In all instances, if you believe yourself to be in immediate danger call the police – 110

GERMAN EMERGENCY SERVICE: 110 (Medical/Police) or 112 (Fire)

### **Car Security**

High visibility retro reflective jacket (safety jacket/ reflective vest) must be carried inside the vehicle when using it. In case of stopping of a vehicle in an area where waiting and parking are forbidden all vehicle occupants must wear a reflective vest for safety and by law.

Many of us will purchase new cars while serving overseas. A lot of new cars have keyless technology, mainly a convenience such as helping save time when carrying shopping bags or trying to duck out of the rain.

Thieves have now identified a way to scan and record keyless card details. To avoid having your car stolen it is recommended keeping your car key away from your front door, if possible, in a metal tin. This will help mask the digital signature of the key.

## Use of Social Media

Most people think a Virtual Private Network (VPN) is just another way to watch UK TV in Europe.

It is also the best way to secure your internet, protect your personal information and the information you are sending/receiving when using the internet.

Wi-Fi hotspots that don't ask for a log on or password to use are particularly vulnerable to hackers who will intercept your information. This could lead to your identity being stolen or your bank details being copied.

It is recommended that you use a VPN to secure yourselves. Some are free and some you purchase. A paid for VPN provider is more secure than a free VPN, as free VPN providers tend to sell your information on to make a profit. Some VPN providers to consider are:

## **Fitness Apps and Tracking Devices**

Most of us use fitness tracking devices, be it via smart phone or through a smart watch. There is evidence to suggest that these devices are tracking our movements and sharing our data.

If you use these devices it is suggested that you follow these easy steps:

Lock down/apply privacy settings on any media account where location data could be available to prevent unauthorised/uninvited access.

Opt out of any heat map data collection or enable privacy zone functionality using application settings

Turn off GPS on any application when not required.

### **Phishing Scams**

Phishing is a form of fraud in which an attacker masquerades as a reputable entity or person, through email and other communication channels, to induce individuals to reveal personal information such as passwords and bank account details.

Phishing scams have been around since the internet first existed and are not likely to disappear any time soon. There are however several ways you can prevent falling victim such as using Antivirus Software and Firewalls and thinking before you click.

## **Telephone Connections/Disconnections & Mobile Phones**

The country code for Germany is +49. e.g.: 0049 (0)65 44 70 75

When dialling the UK from Germany dial: 0044 then drop the first zero from your number e.g.: 0044 (0) 2081 112222

Your sponsor should show you where and how to get internet service. The only thing you require to open an account are your bank details.

There are a number of internet and telephone providers which have shops in the centre of Goch, although Deutsche Telecom holds the monopoly on telephone landline contracts and internet services (looks like a T-Mobile shop, pink T). Companies mandate a minimum 2-year rental contract. A minimum notice of 3 months is usually required for termination. Early termination can incur charges. You can obtain a notification letter from the NATO HQ stating you are being posted and companies have been known to waive the outstanding contract charges.

Downloading movies and television through the German internet is heavily frowned upon by the German authorities. Internet providers will give names, I.P addresses and details of individuals to legal companies who will send fines for downloading such material. Fines can be up to €800 per offence.

#### **Television**

### **Quiet days**

Germans take their days off quite seriously and one example of this is the law that assures no unnecessary noise is made on Sundays and public holidays. It is recommended that you don't wash your car, cut the grass, make repairs or even hang up laundry. Most Germans still regard Sunday as a day of rest and with that all shops are closed except perhaps a bakery or two for Sunday Frühstuck (breakfast). Quiet hours are stipulated as between 2200-0700 every day and all day on a Sunday.

## **Public Holidays**

As a predominantly Catholic country Germany observes various holidays throughout the year. In NRW there are 11 days set aside as public holidays, 2 of which always fall on a Thursday. This then enables a 4-day weekend with the Friday known as Bridging Day (Brückentag) It is worth noting that different regions in Germany may have different public holidays.

## Recycling

Schöenmackers are the dedicated refuse disposal organization for our area. All glass bottles, recyclable items and paper waste are to be separated, dustbins and crates are provided for refuse disposal as follows:

Brown bin: Garden waste and vegetable peelings

Blue bin: Paper and cardboard

Yellow bin: plastic and tins - washed out

Black bin: all other waste

Crates: glass bottles and jars must be separated by colour. Broke glass must not be placed in the crates and corks must be removed from glass bottles.

'Schadstoffe' e.g old batteries, electrical items, medication, oil and other chemicals are not to be disposed with your normal waste. There are certain days throughout the year where you can take your 'Schadstoffe' direct to Schöenmackers between set times.

### Pfand system

The Pfand system in Germany means that consumers pay a deposit on glass and plastic bottles Don't throw away your empty bottles if they have the signal of "Pfandflasche" which means bottle deposit. This sign means that you paid an amount in advance, which is usually 25 cents per drink, which you can get back in most supermarkets through a machine.

## **Tax Free Shopping**

There are two options for tax free shopping.

Through NATO, your sponsor will take you through this process.

UK via the NSE, upon arrival, the HNLO will discuss this process with you.

#### **Tax Free Vehicles**

Each entitled person is permitted to register only one new tax-free vehicle within any one-year period. In addition to one tax-free vehicle, one tax-free motorcycle/quad bike, moped or bicycle with auxiliary motor, may be registered within any one-year period. However, only one vehicle per 'Entitled person' per year can be exported to the UK free of tax.

## **Tax Free Shopping**

There are two options for tax free shopping.

Through NATO, your sponsor will take you through this process.

UK via the NSE, upon arrival, the HNLO will discuss this process with you.

The full document on how to claim tax free goods is available from the NSE.

#### **Tax Free Vehicles**

Each entitled person is permitted to register only one new tax-free vehicle within any one-year period. In addition to one tax-free vehicle, one tax-free motorcycle/quad bike, moped or bicycle with auxiliary motor, may be registered within any one-year period. However, only one vehicle per 'Entitled person' per year can be exported to the UK free of tax.

## GENERAL GUIDANCE FOR IMPORTING A PRIVATE VEHICLE TO THE UK.

This information is only for personnel reimporting a personal vehicle to the UK from another EU member state (<a href="https://www.gov.uk/importing-vehicles-into-the-uk">https://www.gov.uk/importing-vehicles-into-the-uk</a>) for further guidance.

Contact the VLO Clerk at the NSE <u>craig.fitches100@mod.gov.uk</u> who will assist you through the process which will take approximately 28 days. Please contact the VLO Clerk prior to the 28-day point to ensure you are fully aware of what documentation will be required.

Personnel are required to deregister their vehicles prior to returning the vehicle to the UK.

### NATIONAL INSURANCE CREDITS

For spouses who accompanied their partner overseas it is possible to apply for National Insurance Credits, which help fill the gap accrued during an overseas posting. Class 1 credits can be applied for, for any overseas posting after 6 April 2010, but there is a time limit. Class 1 national insurance credits count towards your State Pension and may help you qualify for some other benefits, for example new style jobseekers allowance and new style support and employment allowance. This process must be completed <u>prior</u> to leaving SHAPE. The form (MODCA1) can be downloaded from this website, or alternatively the CLO has copies which can be collected. The Unit Welfare Officer must complete the second section.

## DE-SOFA-ING OF PASSPORTS

#### **SOFA Stamps**

The SOFA stamp should be removed prior to departure and handed to the Admin Clerk, along with SOFA cards and Dependant IDs.

### **NATO Travel Orders**

The NATO travel orders have an expiry date and it is recommended for personal security that these are destroyed upon return to the UK.


## CERTIFICATE OF GOOD CONDUCT

It is highly recommended that both military and spouses complete this process when departing Germany so that you are able to fill in any blanks with regards to your criminal record and your employment. It is especially important when applying for jobs, if you are planning on working with vulnerable people or children.

It is very easy to complete and you usually receive the certificate within 2-3 weeks of applying.
