

Bonham Plain Wood - Disputed Case

Purpose

- 1. The purpose of this paper is to provide an overview of the key issues associated with a disputed case, namely, England Woodland Creation Offer (EWCO) 032 21-22 Bonham Plain Wood. This paper has been produced to support the South West England Forestry and Woodlands Advisory Committee (FWAC) in this disputed case arising from a sustained objection from a statutory consultee.
- 2. The paper also provides a background to the woodland creation proposals at Bonham Plain, including the Woodland Creation Planning Grant (WCPG) Case ref: NP-WCPG-03-18-19 Bonham Farm, Environmental Impact Assessment (EIA) Case ref: EIA-2020-0418 and details of other comments and issues raised through the consultation process from other (non-statutory) parties.

Disputed Case

A disputed case occurs when a statutory consultee sustains an objection to a woodland creation grant proposal that the Forestry Commission (FC) believes to be acceptable because it meets the requirements of the UK Forestry Standard (UKFS).

Objections might include:

- A National Park Authority or Area of Outstanding Natural Beauty concerning a designated landscape
- Natural England concerning a designated site for nature
- Historic England concerning a designated historic environment site or feature

Disputed cases are exceedingly rare as nearly all conflicts are resolved satisfactorily at the consultation stage by amending the proposals through mutual agreement.

There are three key steps to address a disputed case:

- 1. FC officials dealing with the application seek a local resolution
- 2. The case is referred to the region's Forestry and Woodland Advisory Committee to seek conciliation and compromise
- 3. The last stage is a referral to the Commissioners for a final decision

With regard to EWCO 032 21-22 Bonham Plain Wood, it is the FC's view that the proposals are acceptable as the scheme meets the requirements and guidelines of the United Kingdom Forestry Standard (UKFS).



The Cranborne Chase Area of Outstanding Natural Beauty Partnership (CCAONB) has a different view and has sustained the objection to the EWCO application proposals.

Regarding 'Step 1' above, the FC has sought to seek a local resolution, but this has not been achieved / possible.

As a result, the FC Area Director sought confirmation from the Director of Forest Services that the case should be accepted for consideration as a disputed case. This was confirmed on 28th September 2022.

We are now at 'Step 2' and the case has been referred to the SW FWAC.

The primary role of the FWAC is to explore the scope for a compromise between the applicants and the objectors that would be technically, legally and administratively acceptable to the FC.

If a compromise cannot be agreed, and the objection is sustained, then the FWAC is required to report to the Forestry Commissioners who will then make the final decision on whether to uphold the objection.

Paper 2 - Forestry & Woodlands Advisory Committees & Disputed Cases has been produced by the FC Commissioners' Office. This covers the Disputed Case process, the role of the FWAC, purpose of the FWAC sub-committee meeting, roles, responsibilities and what happens after the meeting.

Outlined below is background on the WCPG, EIA and EWCO applications. The subject of this disputed case is the EWCO application.

WCPG - Case ref: NP-WCPG-03-18-19 Bonham Farm

The WCPG application for Bonham Farm was submitted on 9th April 2018. The WCPG supports the production of a UKFS compliant woodland creation design plan (WCDP). https://www.gov.uk/government/publications/the-uk-forestry-standard

The WCPG is a voluntary process to support evidence gathering and does not include a formal process of consultation with or notification of statutory and non-statutory bodies.

The WCPG process helps identify who the key stakeholders are. All statutory consultees for grant applications, such as EWCO and for EIA regulatory processes are identified as part of the WCPG stakeholder engagement process.



The WCPG process provides an early opportunity for the proposer to engage with them and to gather evidence which can be used to inform the Woodland Creation Design Plan.

Forestry Commission approval of a WCDP does not provide approval to plant.

The WCDP for Bonham Plan Woods was approved by the Forestry Commission on 1st May 2020.

FIA - Case ref: FIA-2020-0418

The EIA application seeking the FC's view of the environmental impact of the afforestation proposal was submitted on 23rd November 2020 (EIA Case ref: EIA-2020-0418).

The planting design was revised following EIA screening. 'BPW 10 - Bonham Farm WCDP Map 8 Planting Design - V1 EIA revised' shows the revised design.

The FC completed the EIA screening on 8th July 2021. It is the FC's opinion that this proposal does not require FC consent under the EIA Regulations. An Environmental Statement is not required. This decision is valid for five years from the date of the opinion letter (8th July 2021). The applicant is free to start the woodland creation project at any point during this five-year period. EWCO - Case ref: NP-EWCO - 32 21_22 Bonham Plain Wood

EWCO application 32 21_22 Bonham Plain Wood was received by the FC on 5th July 2021 and following checks and additional information requested from the applicant, passed to the Area Team Woodland Officer on 28th October 2021.

The EWCO application is based on the revised design following the EIA process and FC opinion.

The planting proposal was published on the Consultation Register for Grant Schemes, Felling and EIA applications and was open for comments until 30th November 2021. The Consultation Public Register is in place to notify the public of, in this instance, a woodland creation grant application, and to provide the public with 28 days in which to ask for more information on the proposal, or to submit comments on the proposal.



Separately, and independently of the Consultation Public Register period, the FC conducted statutory and non-statutory consultation and notification.

As part of the consultation process, the applicant held a site meeting on Thursday 31st March 2022, attended by the CCAONB Principal Landscape and Planning Officer and FC Officers. Historic England were also invited but did not attend. This meeting was a very useful opportunity to clarify and exchange opinions, but it did not resolve the issue.
