Thank you for your email received by the Ministry Of Defence on 28/01/2024 requesting the following information:

"Year's 2022 and 2023 latest available data.

As above can you please tell me those who have left the three services, by service and year. The information required is those who have left the Army rank Captain and above. The Navy Sub Lieutenant and above. The Airforce Pilot Officer and above."

We are treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

We have now completed a search for the information you requested, and I can confirm that all information in scope of your request is held. Please find the number of Officer OF-1 and above (Royal Navy / Royal Marines and Royal Air Force) and Officer OF-2 and above (Army) Outflow from the UK Regular Forces and FR20 in the 12 months to 30 September 2022 and 2023 in Table 1 and Table 2 below.

- 7. There are a small number of personnel within the Royal Air Force which are being captured in the OF-1/OF(D), however for Pay purposes their NATO rank is within the Other Ranks.
