We refer to your email dated 04 January 2024, which we acknowledged on 04 January 2024.

We are treating your email as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your email you requested the following information:

• The total number of uninsured vehicles seized by your constabulary annually from 1st January 2019 to 1st January 2024.

• A detailed breakdown of the seized vehicles by year, including, but not limited to: o Type of vehicle (e.g., cars, motorcycles, commercial vehicles).

o Reasons for seizure (e.g., routine checks, accidents, tip-offs).

• A detailed breakdown of any enforcement measures taken against the owners or drivers of the seized uninsured vehicles, including, but not limited to:

- Fines,
- Penalties
- or other legal actions.

Can the above-mentioned information please be supplied in excel format and the data be categorised as per the bullet points above.

A search for information has now been completed and I can confirm that we do hold information in scope of your request, which is presented in the following table:
