Trust Change

Project: To discuss the application from Cams Hill School (SAT) to join Gateway Multi Academy Trust, Hampshire.

AB discussion:

- The board discussed the CEO role and capacity to support the school.
- The performance of Gateway's schools was discussed by the board, including progress measures for disadvantaged pupils.
- The overlap between board members and the local governing body was discussed.

RD decision: Approve.

Converter Academy Order

Project: To discuss application from Rusthall St Paul's Church of England VA Primary School to join Inspire Academy Movement Trust, North Kent.

- A need for the school to receive support was discussed, alongside potential risks associated with the conversion.

- The board highlighted the risk associated with the condition of the school buildings.

- Oxfordshire County Council updates Woodeaton Manor School website to ensure full transparency.
- Oxfordshire County Council agree a capital support package for Propeller prior to the school joining the trust.
