FREEDOM OF INFORMATION ACT 2000: MINISTRY OF DEFENCE POLICE: ENFORCEMENT IN THE PUBLIC AREA

We refer to your email dated 22 January 2024 to the Ministry of Defence Police (MDP), which was acknowledged on 22 January 2024.

We are treating your email as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your email you requested the following information:

Documentation which would establish that constables of the Ministry of Defence are bound in their duties and obligation to act under an oath of attestation as are the civilian police.

Documentation which would authorise and empower a constable of the Ministry of Defence Police to enforce "The Road Traffic Acts" on public roads and highways, exclusive of military roads which have public access.

A search for information has now been completed I can confirm that the MDP does hold information in scope of your request.
