### **Converter Academy Orders**

## Project: To discuss the conversion of Eldon Primary School, Enfield - to join Children First Academy Trust, Enfield

**AB discussion:** Eldon Primary School is a 2 to 11 community primary school in Enfield. It has applied to convert to academy status and join Children First Academy Trust, a trust comprising of five primary schools in the same local authority. Eldon Primary School was rated good by Ofsted in Feb 2022.

AB members discussed rationale for school to join the trust including sharing good practice, financial sustainability and enhanced curriculum.

AB members discussed risks including falling school rolls and recruitment.

Further actions required: Inform the school, trust and local authority of the decision.

# Project: To discuss the conversion of Dollis Primary School, Barnet - to join Bellevue Place Education Trust (BPET) MAT, Wandsworth

**AB discussion:** Dollis Primary School is a 2FE community school in Barnet with 454 pupils on roll. In 2019, Dollis Infant School and Dollis Junior School amalgamated to form Dollis Primary School. Dollis Primary was rated good in September 2023.

The school has applied to convert to academy status and join Bellevue Place Education Trust (BPET), a primary based MAT with 11 schools, all judged good or outstanding.

AB members discussed BPET's growth strategy and geographical spread of its schools.

AB members discussed risks including pupil rolls and trust finances.

Recommendation to deploy SRMA.

AB members discussed site survey carried out by BPET on the school building for Dollis Primary School.

AB members discussed the trust's school improvement strategy.

**Further actions required:** Inform the school, trust and LA of the decision. Discussion with trust regarding the strategic plan and school improvement model.

## Project: To discuss the conversion of Columbia Primary School, Tower Hamlets - to join The Letta Trust, Tower Hamlets

**AB discussion:** Columbia Primary School (CPS), a 3 to 11 community primary school in Tower Hamlets, has applied to convert to academy status and join The LETTA Trust. CPS was rated good by Ofsted in July 2023.

The LETTA Trust is a small two school trust with strong educational performance which has capacity and is keen to grow. The addition of CPS will help the trust to be more sustainable in the longer term. Noted, that relationships across the two organisations are already strong and well established.

AB discussed risks including financial management.

# Project: To discuss the conversion of St Michael's Catholic Primary School, Newham - to join Our Lady of Grace Catholic Academy Trust, Newham

**AB discussion:** St Michael's Catholic Primary School, a 3-11 voluntary aided school, has applied to convert and join Our Lady of Grace (OLOG) Catholic Academy Trust, which is an established trust in the Diocese of Brentwood, operating 6 primary academies in Newham - five rated Ofsted Good and one rated Ofsted Outstanding.

St Michael's already has a relationship with the trust and by joining the trust they will formalise their collaborative working and benefit from the shared services offered.

AB discussed risks including finances. Recommendation made for an SRMA deployment.

# Project: To discuss the conversion of London Nautical School, Lambeth, to join City of London Academy Trust, City of London

**AB discussion:** London Nautical is a specialist maritime school in central London. The school had been considering options for academisation before Covid.

Recent Ofsted has judged the school to Require Improvement, this will be the school's second judgement of RI.

They have been working with the City of London Academy Trust for several years.

AB discussed exclusion rates.

AB supportive of the proposal.

# Project: To discuss expansion of specialist resource unit at Kensington Aldridge Academy, Kensington and Chelsea - to allow 16-18 students to utilise the provision

**AB discussion:** Kensington Aldridge Academy (KAA) is a 11-18 mixed secondary single academy which opened in September 2014. The academy is non-selective with students across the ability range with most students living close to KAA. The school's lead Sponsor is Aldridge Education, and the co-sponsor is the Royal Borough of Kensington and Chelsea.

In August 2022, the Regional Director approved a significant change application from Kensington Aldridge Academy to expand the school by 8 classrooms and increase the PAN by 180.

The trust is now seeking approval for provision to be expanded at the school's Grandin Centre autism unit; 4 students in Y12 and 4 in Y13, which will extend provision at the centre to year 7 to year 13.

This will reduce the need for some KAA pupils to leave the school after the age of 16 and move to other schools and colleges in the LA or further afield as well as allowing students with EHCPs at other schools to potentially take post 16 qualifications at KAA.

## Project: To discuss Alexandra Park School (part of New River Trust), Haringey - expanding its sixth form

**AB discussion:** Alexandra Park School (APS) is the only school in the New River Trust. It converted to become an academy in 2011. The school was judged Outstanding in its last two Ofsted judgements.

The school is proposing to expand the size of the existing sixth form from the published PAN of 275 to 385. This will help address the shortage of sixth form places across the borough.

The LA is supportive of this proposal as the Haringey School Places Planning Review 2022 and 2023 indicated that schools in its borough with sixth form places are either full or close to capacity.

Noted that the new building will be self-funded.

# Project: To discuss the transfer of The Jubilee Academy AP School (part of The Harrow Alternative Provision Academy Trust), Harrow - to join Tithe Academy Trust, Harrow

**AB discussion:** The Jubilee Academy (TJA), an alternative provision (AP) secondary free school and a single academy trust, has made a voluntary transfer application to join Tithe Academy Trust. TJA was judged Outstanding by Ofsted in April 2023.

Tithe Academy Trust has two academies, Rooks Heath Secondary and Earlsmead Primary. The CEO of Tithe, Dr Reavley, led on establishing TJA free school and has also been the Executive Headteacher at TJA since 2014.

If approval is given to TJA to join Tithe Academy Trust, the trustees of TJA will become the Local Governing Body within the Tithe governance structure.

AB members discussed places available at the trust.

# Project: To discuss the transfer of Thomson House School (part of STAMP Education Trust), Richmond upon Thames – to join Wandle Learning Trust, Wandsworth

**AB discussion:** This proposal is for Thomson House School (THS), a 2FE primary free school based in Richmond upon Thames, to voluntarily join Wandle Learning Trust (WLT).

WLT is a mixed MAT of one secondary school, Chestnut Grove School, and three primary schools, Chesterton Primary School, Paxton Academy Sports and Science and Ravenstone Primary School. The trust currently operates in Wandsworth and Croydon. Trust schools have 'good' and 'outstanding' Ofsted judgements.

AB members noted that the project was low risk, however challenged the high level of reserves held by WLT. AB members supported the transfer being approved with the recommendation for a School Resource Management Adviser (SRMA) review at WLT next academic year.
