Sec 31 Pupil Premium Plus (PP+) post-16 funding to local authorities Implementation Grant Determination Letter 2024-25 [No. 31/7283]

This determination is made between:

- 1. The Parliamentary Under Secretary of State for Children and Families, and**
- 2. The local authorities listed at Annex A.**

Purpose of the grant

Each local authority in England is required to appoint a Virtual School Head to promote the educational attainment of children in the care of their local authority. Virtual School Heads currently receive Pupil Premium Plus (PP+) funding of £2,570 per child in care, aged 4 to 15. This is used to provide both individual support that a child needs, as identified in their Personal Education Plan, and for the cohort as a whole. This funding ceases when the child reaches the age of 16, but Virtual School Head duties and the need for bespoke support continue for as long as the child is in care.

The purpose of this grant is to provide additional funding for looked-after children and care leavers at post-16 to local authorities in England. The extension will run from April 2024 to March 2025. The total funding available for this period is £13.84m.

This funding will provide support to local authorities in England for expenditure lawfully incurred or to be incurred by them to extend support to looked-after children and care leavers at post-16. This will build an evidence base of best practice which will inform any future support for this cohort of young people.

Local authorities can spend this grant to support costs associated with meeting this duty. In doing so, they should take account of the statutory guidance [Promoting the education of looked-after and previously looked-after children](#) published on 26th February 2018, to help them implement this new duty.

Annex A attached includes the amount of funding awarded to each local authority for the 2024-25 financial year.

PILOT OF PUPIL PREMIUM PLUS POST-16 FUNDING TO SELECT LOCAL AUTHORITIES IMPLEMENTATION GRANT DETERMINATION 2024/25: [No. 31/7283]

The Secretary of State for Education (“the Secretary of State”), in exercise of the powers conferred by section 31 of the Local Government Act 2003, makes the following determination:

Citation

1) This determination may be cited as the PUPIL PREMIUM PLUS POST-16 FUNDING TO SELECT LOCAL AUTHORITIES IMPLEMENTATION GRANT DETERMINATION (2024/25) [No. 31/7283]

Purpose of the grant

2) The purpose of the grant is to provide support to local authorities in England for expenditure lawfully incurred or to be incurred by them in respect of implementing the role of Virtual School Head for post-16 looked-after children and care leavers.

Determination

3) The Secretary of State determines the authorities to which the grant is to be paid and the amount of grant to be paid. The authorities and the amounts are set out in Annex A.

Grant payments and expectations

4) It is expected that the grant will be used in line with the statutory guidance and to continue to develop the evidence base for VSHs working effectively to support post-16 looked-after children and care leavers. LAs may be expected to engage with our research partner in evaluating outcomes for children and young people supported through the grant.

Payment arrangements

5) Grant will be paid in 2 instalments, which will be paid in September 2024 and January 2025. All payments will be paid before the end of financial year 2024-25.

Treasury consent

6) Before making this determination in relation to local authorities in England, the Secretary of State obtained the consent of the Treasury.
