We are treating your email as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your email you requested the following information:

**I am writing to request the following data for the last three calendar years (2020-2023).**

- **The total number of vehicle accidents/ intentional damages to vehicles reported in your local car parks over the past three years.**
- **The total number of thefts from vehicles reported in your local car parks over the past three years.**
- **The total number of assaults reported in your local car parks over the past three years.**

A search for information has now been completed I can confirm that MDP does hold information in scope of your request.

- **The total number of vehicle accidents/ intentional damages to vehicles reported in your local car parks over the past three years.**

Accidents = 14

Intentional damage = 6

- **The total number of thefts from vehicles reported in your local car parks over the past three years.**

Theft of vehicle = 1

Theft of item = 2

**- The total number of assaults reported in your local car parks over the past three years.**

Assaults = 1
