- 87 representations were received for the significant change application for Selwood Academy (SAT), **Somerset**, to change the age range from 9-13 to 9-16.

# **Converter Academy Orders**

Points discussed in relation to school conversion.

**Project:** To discuss Christchurch Infant School, **Bournemouth, Christchurch and Poole** to convert to academy status and join Twynham Learning.

#### Representations received:

No representations were made for this project.

**Points raised in Discussion:** The board members considered the details of the project and did not raise any concerns/comments in relation to the recommendation.

**Project:** To discuss the following five academies to convert to academy status and join Link Academy Trust:

- Woodbury Salterton Church of England Primary School, **Devon**
- Honiton Primary School, Devon

#### Representations received:

No representations were made for this project.

#### Points raised in Discussion:

- Honiton Primary School and the Jubilee with Pebblebed Federation schools have all applied to voluntarily convert.
- Honiton Primary School is a 3-11 Primary school in Honiton, Devon. The Jubilee with Pebblebed Federation consists of four primary schools, Branscombe CofE Primary School, Broadhembury CofE Primary School, Farway CofE Primary School, and Woodbury Salterton CofE Primary School, which are all in the East Devon area.
- Link Academy Trust has the experience, capability, and capacity to drive improvements for the schools and the wider area.
- It was recommended that as the trust grows, they consider a review of the SI model and how to develop the model in line with trust growth.
- The growth strategy of the trust was discussed with a period of consolidation recommended. Regions Group will continue to discuss growth plans with the trust.

• Cullompton Community College (CCC) is a 11-16 Secondary School in Devon. This is a voluntary conversion.

- Blackdown Education Partnership has been supporting CCC through a management partnership and with TSI support.
- CCC will be the sixth secondary school within Blackdown and is geographically close to all other schools in the trust.
- Bishops Hull Primary School is a 4 -11 primary school located in Taunton, Somerset.
   This is a voluntary conversion.
- There has been a partnership agreement in place for the last 12 months between Bishops Hull Primary School and Blackdown.
- AB Members commented on the outcomes for disadvantaged learners and Regions Group have sought assurances from Blackdown Education Partnership.

#### Points raised in Discussion:

- Elmhurst Junior School is a community school in Street, Somerset, which received a Good Ofsted judgement in November 2023, after a second Requires Improvement (RI) judgement in January 2020.
- Elmhurst has gone through significant school improvement since receiving the RI judgement in 2020. The school is looking for the support and backing of a strong, local trust.
- Wessex Learning Trust (WLT) was set up in June 2016, as a sponsor trust and has 17 schools, in Somerset and North Somerset. The trust has experience working with small schools and their communities.
- It was discussed that the Trust Board has recently gone through a period of recruitment and an external review of governance (ERG) should therefore be undertaken. Regions Group will work with the trust on this.
- It was noted by AB members that the CEO is the School Improvement lead and that the trust should consider its leadership structure given the size of the trust. This will be raised by Regions Group.

# **Sponsored academy orders:**

Points discussed in relation to a school's sponsor status.

**Project:** To discuss St Barnabas Church of England Multi Academy Trust to sponsor St Germans Primary School, **Cornwall.** 

## Representations received:

No representations were made for this project.

#### Points raised in Discussion:

St German's is a 3-11 primary school in Cornwall. At the last Ofsted inspection in November 2023 the school was judged Inadequate with serious weaknesses across safequarding, leadership and management, and early years.

- St Barnabas has extensive experience of improving schools. The trust runs primarily small, rural schools. There is confidence in St Barnabas' capacity to secure rapid and sustained improvement at St Germans.
- An External Review of Governance found that trustees have the relevant skills and experience and that the trust vision is strong.
- All schools currently in St Barnabas are Church of England schools, St Germans will be its first community school. Regions Group are assured that the trust will manage this successfully.
- It was recommended that the trust considers a review of the SI model within the next 12 months and how to develop the model in line with trust growth.

**Project:** To discuss Severn Federation Academy Trust to sponsor Rangeworthy Church of England Primary School, **South Gloucestershire.** 

## Representations received:

• No representations were made for this project.

#### Points raised in Discussion:

- Rangeworthy CofE Primary is a 5-11 Church of England (VC) primary school which at its last Ofsted inspection in September 2023 was judged Inadequate.
- Severn Federation Academy Trust (SFAT) are based in the Forest of Dean. AB
  Members discussed Rangeworthy being isolated from other schools within the trust.
  However, SFAT has given assurances it has the capacity to deploy personnel from
  the school improvement team to meet the needs of the school.

- SFAT have a recent track record of improving small rural schools and making rapid improvements. SFAT have been actively engaged, already working with a cluster of schools in South Gloucestershire.
- It was recommended for the CEO to have a mentor to provide positive and constructive support as the trust grows.

## Significant changes to an open academy

Points discussed in relation to significant change application(s).

**Project:** To discuss a significant change for Selwood Academy (SAT), **Somerset**, to change the age range from 9-13 to 9-16.

#### Representations received:

• 87 representations were received in relation to this proposal.

#### Points raised in Discussion:

- The delivery team outlined the Academy's proposal. Selwood Academy is a middle-deemed secondary SAT in Frome. It currently serves pupils aged 9-13 and is applying to extend its age range to 9-16. Since becoming an academy, Selwood has been rated Ofsted Good at full inspections in 2012 and 2022. Selwood is proposing to extend its age range from Years 5-8 to an extended middle school serving Years 5-11. The change would be phased and would involve reducing PAN at Y5. The project is fully budgeted and would be managed using the Academy's reserves.
- The delivery team outlined the Academy's arguments for the change, highlighting:
  - o They argue that a disproportionate number of Frome-resident children are educated outside of the town − 1,000 pupils, and 1-in-3 by Y11.
  - There is a significant demand from the parent community to have their children educated at Selwood for their whole secondary career.
  - There is demand from the local community for the option of a secondary Church school in the town.
  - o The project will not require any external funding.
  - The head teacher has previously led and improved secondary schools, and many academy staff are secondary trained or have secondary experience.
- The delivery team outlined concerns related to the project, highlighting:
  - There is no demographic need for more places in the Frome secondary phase. Departmental guidance advises against creating surplus places unless in exceptional circumstances. The figure of 1,000 Frome pupils being educated outside of the town could not be substantiated using available data.
  - This is a proposed unilateral change in the context of recent conversations on changes to the three-tier structure in the town. Many schools in the town have voted to join multi-academy trusts since the academy's consultation.

- Key stage 2 outcomes at the academy are below national averages.
- The proposed change will likely have an adverse impact on Frome Community College (FCC) – with the potential for the upper school to lose up to 360 children across Y9-11 once the change is fully implemented. There is no evidence of a co-ordinated implementation plan involving FCC and other local schools.
- The delivery team noted the large number of representations received and outlined key points in support of the change, particularly from the Academy's parent community, a local school, a local multi-academy trust, and from representatives of the Methodist education community. Representations from those with concerns about the change were also noted, including from local schools, multi-academy trust leaders, the Diocese of Bath and Wells, and a representative of the town council. It was also noted that the local authority conditionally consented to the change, though their strong preference would be for any change to Frome schools to be a part of a coherent, system-wide reconfiguration.
- The delivery team highlighted a previous local age range change within the three-tier system and set out why the specific context and circumstances of that case was not comparable and did not set a precedent for this proposal.
- The Regional Director expressed concern around the need for system co-ordination and strong evidence of quality when proposing a change like this.
- In discussion, Advisory Board members highlighted a number of concerns, namely: a lack of confidence in the academy trust being able to deliver a broad and balanced curriculum and enriching wider educational offer at KS4 based on its current track record and proposed pupil numbers; caution around the unusual 9-16 age range; concerns around the unilateral nature of the change and potential impact on other providers; and concerns around whether the impact of this change, in creating two providers with small KS4 cohorts, would be an efficient use of public money. Advisory Board members also recognised the strength of parental feeling and public demand for a church KS4 provider.

RD decision: Decline.

# **Trust Changes**

Points discussed in relation to academies moving to another trust.

**Project:** To discuss Harrowbarrow School (SAT), **Cornwall** to join Bridge Multi-Academy Trust.

## Representations received:

• No representations were made for this project.

#### Points raised in Discussion:

• Harrowbarrow School is a 4 – 11 primary converter which opened in 2012. The school is in the east of Cornwall in Callington.

- The school received a second Requires Improvement Ofsted judgement across all areas in November 2023, the first Requires Improvement Ofsted judgement was received in February 2020.
- The values and ethos of Bridge MAT align with those of Harrowbarrow School, and the trust is already supporting the school. Staff have been offered full access to its CPD offer as well as supporting joint English and Maths moderation.
- Bridge MAT has the capacity to deploy School Improvement support at pace and has a proven track record of improving underperforming schools in the South-East Cornwall area and in rural settings.
- The trust had an External review of Governance (ERG) in December 2023 where it
  was recommended to remove the overlap of the chair as a member and trustee as
  well as considering growth of the trust board to strengthen its skill set to include
  MAT leadership experience. Regions Group will review progress with the trust.
