Thank you for your request for information of 21st August about Poultry figures. APHA have handled your request under the Freedom of Information Act 2000 (FOIA).

"Under the Freedom of Information Act 2000, can you please provide the number of poultry/egg/layer farms at county level still using caged systems in England, Wales and Scotland?"

The information you have requested can be found at Appendix 1.

The information APHA hold is a current snapshot of the information passed to APHA at the point of registration. It is the responsibility of the livestock keeper to inform APHA of any changes. Please note that the Livestock Unit Husbandry System is not always recorded on registration, and APHA can only provide data on the information that has been declared.

Poultry species included are the ones defined by the Department for the Environment Food and Rural Affairs (DEFRA) being, chicken, duck, goose, guinea fowl, ostrich, partridge, pheasant, pigeon, quail, turkey and rhea.
