I, the undersigned Official Veterinarian, hereby certify that:

1. the bovine bones / hides* / skins* used to manufacture the above product are derived from countries, namely

posing a negligible BSE risk and from cattle which have passed ante- and post-mortem inspection;

AND/OR

◆*2. The bovine bones* / hides* / skins* used to manufacture the above product are derived from countries, namely

(a) posing a controlled BSE risk and from cattle which have passed ante- and post-mortem inspection;

and

(b) distal ileum from bovines of any age; skull, brain, eyes vertebral column and spinal cord from bovines that were at the time of slaughter over 30 months of age have been excluded;

and

(c) the bones have been subjected to a process which includes all of the following steps:

- (i) Degreasing;
- (ii) Acid mineralisation;
- (iii) Acid or alkaline treatment;
- (iv) Filtration;
- (v) Sterilization at $\geq 138^{\circ} \text{C}$ for a minimum period of 4 seconds.

3. The bones* / hides* / skins* and the finished product have not been co-mingled with other tissues and material from cattle posing BSE risk during processing, storage and transport.
