Section 1 – Applications Received

Inspection of licence applications can be requested under the provisions of Regulation 9 of the Goods Vehicles (Licensing of Operators) Regulations 1995 by anybody who holds statutory objector status. Applications may be inspected free of charge at the Office of the Traffic Commissioner in Leeds by any person who carries written authorisation to act in that capacity.

Objections against published applications may be made in writing by a Chief Officer of Police, a local authority, a planning authority or a prescribed trade union or association within 21 days of the date on which notice of an application is published in Applications and Decisions. Objections must be made either on the grounds that any of the requirements listed in Section 13 of the Goods Vehicles (Licensing of Operators) Act 1995 are not met and/or that a nominated operating centre will be unsuitable for use as such. A copy of the objection must be sent by the objector to the applicant at the same time that it is sent to the Traffic Commissioner. The onus of proof in terms of the grounds on which an objection is lodged lies with the objector.

Classification of Operator Licences – There are three classes of licence:

- A **Restricted (R)** licence authorises the use of a goods vehicle on public roads in Great Britain for the carriage of the licence holder's own goods in the course of his trade or business. The licence holder cannot carry goods for other people for hire or reward;
- A **Standard National (SN)** licence allows the licence holder to carry both his own goods and goods for other people for hire or reward, on public roads in Great Britain. He can also carry his own goods on journeys abroad;
- A **Standard International (SI)** licence allows the licence holder to carry both his own goods and goods for other people for hire or reward. These activities can be undertaken both in Great Britain and on international journeys.

Section 3 – Schedule 4 Applications

Schedule 4 to the Goods Vehicles (Licensing of Operators) Act 1995 allows, in certain situations, the transfer of operating centres from one existing licence to either another existing licence or as part of a new licence application. “The application made by Westley Peter Webb, OD2072343, for a restricted goods vehicle operator’s licence to operate three vehicles and zero trailers is refused.

At no point was an interim licence ever granted. The full application was to be considered at a Public Inquiry before myself at 1330 hours on 12 June 2024. The call up letter for that hearing was dated 26 April 2024 and was sent to the correspondence address given to the Office of the Traffic Commissioner on the GV79 application form which is also the same address that appears on the documents received at the Central Licensing Office of the Office of the Traffic Commissioner in Leeds. That call up letter was not returned as undelivered by the Royal Mail. It is more likely than not that it was delivered in the post and it is more likely than not that Mr W Webb was aware of the hearing today.

Mr Webb did not attend. No contact today had been received from Mr Webb to say he was running late or could not be present. The call up letter told him to arrive at least an hour before the start time, i.e. by 1230 hours. I waited until 1345 hours. No one had attended still. No request for an adjournment had been made by Mr Webb at any time. There was no persuasive reason for me to adjourn this case on my own volition. It was fair and it was in the interests of justice to reach a decision in his absence. The call up letter warned him that that would happen (see page 6 of the Public Inquiry bundle, final sentence in bold print).

No documents requested in the call up letter and/or attached Case Management Directions had been received at my office.

As a matter of law all applicants bear the burden of proof to satisfy me that they meet the minimum legal requirements set out in section 13 of the Act.

In light of the failure to attend today and the failure to submit any documents to my office in response to the call up letter/Case Management directions I formally find that all of the allegations made in the call up letter are proven on the balance of probabilities. I therefore remain to be satisfied that the applicant is/has:

- 1. Of sufficient financial resources; and/or**
- 2. Not unfit to hold an operator’s licence; and/or**
- 3. Suitable arrangements to comply with the law regarding drivers hours; and/or**
- 4. Suitable arrangements to ensure that vehicles are not overloaded; and/or**
- 5. Satisfactory facilities and arrangements for maintaining the vehicles in a fit and serviceable condition.**

For each/all of the above findings I therefore refuse this application under sections 13D, 13D, 13C(2), 13C(3) and section 13C(4) of the Act.

Any operation of any vehicle over 3.5 tonnes by Mr Westley Peter Webb was, and remains, unlawful as he has never held, and has now been refused, an operator’s licence. If any such vehicle is operated by him I will ask the DVSA to prosecute him in the criminal courts and I will require the vehicle to be impounded. Mr Westley Peter Webb now has actual knowledge of that.
