Addresses	<p>Addresses have been populated for all charges.</p>	<p><b>Before:</b> Charges were found without an address in charge_geographic_description or charge_address field.</p> <p><b>After:</b> All charges have addresses populated.</p>
Charge types and Charge sub-categories	<p>Charge types and Charge sub-categories have been populated for all charges (with the exception of charge types that do not require sub-categories e.g., Financial charges).</p> <p>The process was introduced to ensure all charge types and sub-categories are correctly populated in the future.</p>	<p><b>Before:</b> Some charges had missing charge types and charge sub-categories.</p> <p><b>After:</b> All charges have populated charge type and charge sub-category.</p>
Originating Authority	<p>The originating authority for Listed Buildings charges are now set to "South Gloucestershire Council".</p>	<p><b>Before:</b> Department of the Environment</p> <p><b>After:</b> South Gloucestershire Council</p>
