- 2) complies with the standards of milk and milk products as specified under the Indian Food Safety and Standards (Food Product Standards and Food Additives) Regulations 2011;

3) conforms to the microbiological requirements specified in Appendix B of the Indian Food Safety and Standards (Food Product Standards and Food Additives) Regulations 2011;

4) has been heat treated by pasteurisation (or an equivalent treatment which produces a negative reaction to the alkaline phosphatase test). State the treatment applied:

5) do not contain drug/antibiotics/mycotoxins/pesticides/heavy metal residues, etc., above the limits prescribed by the Indian Food Safety and Standards (Contaminants, toxins and Residues) Regulations, 2011 and Codex Alimentarius;

The declaration must be provided by an authorised signatory of the manufacturer who has knowledge of, and responsibility for, the relevant parts of the production process.

The manufacturer must have read and understood the 8775EHC and accompanying Notes For Guidance (8775NFG) before completing this declaration.

The exporter must supply a declaration including exactly the same wording as the matters to be certified.

The managing director (or equivalent) of the company should provide a letter giving the name(s) and job title(s) of those authorised to give a declaration ON BEHALF OF THE ESTABLISHMENT, and the basis of which the declaration is made. This must be provided to the certifying OV.

The declaration should include a clause indicating that the signatory is aware that making a false declaration is an offence.
