Many thanks for your email dated 16 December 2023 in which you stated that you are advised by NHS England that having both flu and coronavirus vaccinations will reduce your risk of serious illness (hospitalisation or death) and that at least persons over 75 years of age will recover more quickly if they have both vaccinations. NHS England say that this advice is based on information supplied by the MHRA. You have requested the source on which the MHRA relied for this information.

Please find our response below.

Data assessed by the MHRA that supported concomitant administration of COVID-19 mRNA Vaccine BNT162b2 with influenza vaccines (but at separate injection sites) were based on the ComFluCOV study [EudraCT Number: 2021-001124-18].

The study has been published in the Lancet and is available using the link below:

Dear Sirs,

I am advised by NHS England that having both flu and coronavirus vaccinations will reduce my risk of serious illness (hospitalisation or

death) and that at least persons over 75 years of age will recover more quickly if they have both vaccinations.

NHS England say that this advice is based on information supplied by you. I do not doubt that it is true but I should be grateful if you would let me have the source on which you relied for this information.

Presumably the ultimate source of the above-mentioned information would have statistics based on results of trials or analysis of data relating to vaccinations and non-vaccinations of individuals.

Please would you treat this as a Freedom of Information Request if necessary.

What I seek ultimately are some figures relating to risk of serious illness. E.g perhaps the risk of serious illness is 5% without vaccination, reducing to 2% with vaccination. I appreciate that you may not have such figures but your source or an earlier source would have such figures.

I look forward to your response.
