Thank you for your FOI request dated 18th December 2023.

The data on the website is now static and has not been updated, the statement with the graphs says this: *This page displays the estimated number of vaccines administered alongside the total number of suspected adverse reaction reports received weekly. The doses administered have been estimated based upon data provided by UK Public Health agencies and projected to a UK estimate using national published data on total vaccination doses administered. However, the availability of official vaccination data from the UK Public Health agencies and the data published nationally have changed over time. Please note the estimates presented here do not include first or second doses administered after 11th September 2022. Additionally, after 23rd November 2022 the projection to a UK estimate is based on population estimates published by the Office for National Statistics (ONS).*

During the pandemic the MHRA received some data in collaboration with UKHSA but this has ceased as per the above dates. Therefore the requested information is considered as not held by the MHRA and we would suggest that you contact the UKHSA with this request.

I hope the information provided is helpful, but if you are dissatisfied with the handling of your request, you have the right to ask for an internal review. Internal review requests should be submitted within two months of the date of this response; and can be addressed to this email address.
