Thank you for your email of 30 April 2024 to the Ministry of Defence (MOD), requesting the following information:

" I would be very grateful if you could provide a figure to update a previous FOI reference FOI2023/04453.

This outlined the indexation percentage that had been applied to the CARE Pots from 2016 to 2023.

The request is that it be updated to also show the % indexation to be applied for 1 Apr 23 to 31 Mar 24 AFPS 15 pot inputs."

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the MOD and I can confirm all information in scope of your request is held and is shown below:

The Armed Forces Pension Scheme (AFPS) applies an annual indexation (effective 1 April each year) on the value of in-year (1 April to 31 March) Career Average Revalued Earnings (CARE) Pot inputs. This means simply that money being added to the pension value in any one full scheme-year is then increased on 1 April. Members who discharge part-way through a scheme-year receive a partial indexation of their in-year CARE Pot inputs.

The revaluation orders made by HM Treasury and applied by AFPS are as follows:

Year	Indexation Percentage	Applied to
2016	2%	1 Apr 15 – 31 Mar 16 AFPS15 pot inputs
2017	2.6%	1 Apr 16 – 31 Mar 17 AFPS15 pot inputs
2018	3%	1 Apr 17 – 31 Mar 18 AFPS15 pot inputs
2019	2.8%	1 Apr 18 – 31 Mar 19 AFPS15 pot inputs
2020	4%	1 Apr 19 – 31 Mar 20 AFPS15 pot inputs
2021	2.4%	1 Apr 20 – 31 Mar 21 AFPS15 pot inputs

2022	4.1%	1 Apr 21 – 31 Mar 22 AFPS15 pot inputs
2023	7%	1 Apr 22 – 31 Mar 23 AFPS 15 pot inputs
2024	7.7%	1 Apr 23 – 31 Mar 24 AFPS15 pot inputs
