I, the undersigned Official Veterinarian, certify that for the birds for export as described above:

- c) \*(For commercial birds only) The breeding facility of the birds for export has been registered in accordance with the relevant regulations of the United Kingdom, and has been inspected by an official inspector of the UK competent authority and notified to the head of the animal quarantine agency of the Republic of Korea;
- d) \*(i) (For pet birds) The birds for export have been quarantined at the holding of origin for more than 28 days prior to export without any contact with other birds, and there has been no evidence of any infectious or contagious disease found during a clinical examination by an Official Veterinarian within 3 days prior to export.
  - \* (ii) (For commercial birds) The birds for export have been kept in a quarantine facility approved by the UK competent authority for at least 28 days prior to export and there has been no evidence of any infectious or contagious disease found during a clinical examination by an Official Veterinarian within 3 days prior to export;

- g) Based on a declaration from the exporter, the birds for export will be transported to the place of shipment and to the Republic of Korea in such a manner that will not have any contact with any other poultry, day-old chicks, birds or their products with lower health status. It will also be transported in such a manner that will prevent contamination by any pathogens of infectious or contagious poultry diseases;
- h) Based on a declaration from the exporter, during transportation to the Republic of Korea the birds for export will not pass, except for simple stopover at a port/airport for fuel etc. while remaining on the same vehicle, through areas from which the Republic of Korea does not permit the import of poultry, etc.;
- j) \*(In the event of an HPAI outbreak in the UK, until all restricted areas established in the UK due to outbreaks of HPAI are lifted)
