2. The cost associated with the software. Please provide me with the annual spend.

- 4. What is the duration of the contract?
- 5. When does this contract expires?
- 6. When does the organisation plan to review this contract?

7. Can you please provide me with the contract description of the services provided under the agreement with the supplier? This also includes potential extensions and support and maintenance services.

- 8. What is the organisation's annual energy spend for the following:
 - a. Electricity
 - b. Gas
 - c. Water
- 9. What is the total number of meter points for Electricity for:
 - a. Non Half Hourly (NHH) meter points

- 10. What is the total number of Gas meter points?
- 11. What is the total number of Water meter points?

12. What is the total number of meter points for specialist gases and liquids?

13. Can you please provide me with the contact details of the key person responsible for this contract or around energy management.

14. Can you please send me the organisations' energy management strategy/plan that covers 2018"

Your response

Thank you for your information request which was received on 14 November 2023. I have processed your request under the Environmental Information Regulations ('EIR') 2004 ('the Regulations') because the information you have requested concerns work affecting the environment according to the definition in Regulation 2. Section 39 of the Freedom of Information Act ('FOI') 2000 ('the Act') exempts environmental information from the Act but requires us to consider it under the Regulations.

I confirm that MHRA some of the information. I have taken each question in turn.

- 1-7) We do not have an EMS and do not hold the information.
- 8) Annual spend on
 - a) Electricity £1,528,813
 - a) Gas £732,134
 - b) Water £49,140
- 9) number of electricity meter points
 a) non-half hourly meter points =0
 b) half hourly meter points =3
- 10) number of gas meter points = 2
- 11) number of water meter points = 2
- 12) number of specialist gas/liquid meter points = 0

13) Utility contracts are decided/awarded by central government mandate, MHRA does not chose utility providers

14) As an ALB, the MHRA has the same requirements as other government organisations. There was no documented energy management strategy/plan covering the whole of the MHRA in 2018
