Thanks you for your requests on 21 March 2024 regarding the number of batches used in the roll-out of the COVID-19 vaccinations in the UK for the three most common vaccines (obviously Pfizer, AZ and Moderna).

We can provide the number of batches of COVID vaccines that were certified by MHRA/NIBSC for use in the UK during the period Dec 2020-Dec 2023 (no recent batches have been tested for the UK vaccination programmes since Dec 2023). Those batches certificated in December 2020 would be available then to commence vaccinations in January 2021. The number of batches that were 'used' may differ. Once a release certificate is issued to a manufacturer by MHRA/NIBSC, we would not know what is then used in the UK, and therefore do not hold that information.

To provide information therefore on number of batches that were certificated, please see the responses below.

Please provide a breakdown of the number of different batches used since the roll-out of the COVID-19 vaccinations in January 2021 up until today, for the three main brands used in the UK.

1. Number of batches of Pfizer vaccines used since January 2021 to date

Response - Number of batches of Pfizer vaccines issued a release certificate by MHRA/NIBSC in the period Dec 2020 – December 2023 was 119.

2. Number of batches of AstraZeneca used since January 2021 to date (obviously this brand is no longer used).

Response – Number of batches of AstraZeneca vaccines issued a release certificate by MHRA/NIBSC in the period Dec 2020 – December 2023 was 104.

3. Number of batches of Moderna used from January 2021 to date.

Response – Number of batches of Moderna vaccines issued a release certificate by MHRA/NIBSC in the period Dec 2020 – December 2023 was 137.




