REQUEST FOR INFORMATION: Poultry Statistics

Thank you for your request for information of 4th October about Poultry Statistics. APHA have handled your request under the Freedom of Information Act 2000 (FOIA).

Your information request and our response are set out below.

"I would like to request the following information:

Location of all existing Free Range and Colony Poultry sites (egg laying farms) across the UK as of Jan 23

I would like you to provide this information in the following format:

Name of the farm, address, flock size (amount of birds on site), how many units (sheds), co-ordinates."

The information requested can be found at Appendix 1. The information provided is current at the time of this response.

APHA does not have a classification of 'colony' but classify the farm management systems as free range, extensive, intensive and organic as defined within the link below. APHA does not have a record of number of 'sheds'. The information provided is per herd reference which is equivalent to the number of livestock units

It is only compulsory to register flocks of poultry of over 50 birds with APHA.

Owners/Keepers can voluntarily register flocks of less than 50 birds. To find out more about the registration of birds visit the GOV.Uk website for information here:

The information provided are the livestock numbers provided by the keeper upon registration. As part of the registration process, APHA ask the keeper what their usual stock numbers are, and this is recorded in the APHA database. It is the responsibility of the owner/keeper to keep APHA informed of any number changes.

APHA do not hold historical information and any stock numbers and only show what they are on the day the report was run.

APHA is an Executive Agency of the Department for Environment, Food and Rural Affairs and also works on behalf of the Scottish Government, Welsh Government and Food Standards Agency to safeguard animal and plant health for the benefit of people, the environment and the economy.

Any blank entries is because the information was not recorded at the time of registration. Livestock numbers with 0 is because there was no stock to record at the time of registration and APHA have not been informed since of any changes by the owner/keeper.

Part of the information that you have requested name of the farm and address has been exempted from release under Section 40 of the Freedom of Information Act (FOIA) 2000.

Section 40

The data has been supplied at county level and premises with less than 5 birds has been labeled as less than 5 as in some instances the exact number could lead to the identification of the premises. We confirm that APHA does hold the information that you have requested as detailed above, but we have decided that some of the information should be withheld under sections 40(2) and 40(3A) of the FOIA as the information constitutes personal data relating to persons other than you.

These sections exempt personal information from disclosure if that information relates to someone other than the applicant, and if disclosure of that information would breach any of the data protection principles in Article 5(1) of the General Data Protection Regulation (GDPR).

APHA is an Executive Agency of the Department for Environment, Food and Rural Affairs and also works on behalf of the Scottish Government, Welsh Government and Food Standards Agency to safeguard animal and plant health for the benefit of people, the environment and the economy. We consider that disclosure of this information is likely to breach the first data protection principle, which provides that personal data must be processed lawfully, fairly, and in a transparent manner. Disclosure would not constitute 'fair' processing of the personal data because, it would lead to the identification of 3rd parties.

Information disclosed in response to this FOI request is releasable to the public. In keeping with the spirit and effect of the FOIA and the government's Transparency Agenda, this letter and the information disclosed to you may be placed on GOV.UK, together with any related information that will provide a key to its wider context. No information identifying you will be placed on the GOV.UK website.
