### **DECISION**

The sum of £277 per calendar week will be registered as the fair rent with effect from 15 July 2024 being the date the Tribunal made the Decision.

#### **SUMMARY REASONS**

# **Background**

1. Following an objection from the Tenant to the determination of a fair rent by the Rent Officer, the Tribunal has made a determination under the provisions of the Rent Act 1977.

# Inspection

2. The Tribunal did not inspect the property but considered this case on the basis of the papers provided by the parties, its own knowledge (see below) and from Google Maps.

#### **Evidence**

3. The Tribunal has considered the written objection by the Tenant to the Rent officer. There were no written submissions from either party in the Tribunal.

### **Determination and Valuation**

4. Having considered our own expert, general knowledge of rental values in the area, we consider that the open market rent for the property in its current condition would be in the region of £2,850 per calendar month / (£658 per week). From this level of rent we have made adjustments in relation to:

Drafty windows

- 5. The Tribunal has also made an adjustment for scarcity.
- 6. The full valuation is shown below:

7. The Tribunal determines an uncapped rent of £500 per week.

### **Decision**

8. The uncapped fair rent initially determined by the Tribunal, for the purposes of section 70, was £500 week. The capped rent for the property according to the provisions of the Rent Acts (Maximum Fair Rent) Order 1999 is calculated at £277 per week. The calculation of the capped rent is shown on the decision form. In this case the lower rent of £277 per week is to be registered as the fair rent or this property.
