A proposal for a terrace formed part of a previous planning application (ref. 23/00975/F) affecting Building 11. The terrace was subject to verbal (to the Case Officer) objections from the Council's Urban Design and Conservation Officer. Whilst amendments were made to the terrace to seek to overcome the objections, the Council was unwilling to support the terrace element of that application and it was withdrawn from the scheme prior to it being approved so to avoid an outright refusal.

It was agreed with the Case Officer that the terrace should be submitted as a standalone application which it would refuse so that we could make an appeal. Bristol City Council has since been placed in special measures so the application is now made directly to the Secretary of State.
