### **Non-Technical Summary**

This Noise and Vibration Monitoring Report fulfils HS2 Limited's commitment detailed in the Environmental Minimum Requirements (EMRs), Annex 1, Code of Construction Practice, to present the results of noise monitoring carried out within the Lichfield District Council (LDC) area during the month of May 2024.

Within this period monitoring was undertaken at the following worksites:

- Noise monitoring was undertaken in the vicinity of the Shaw Lane Embankment (ref.: SLE) worksite no works were underway.
- Noise and vibration monitoring was undertaken in the vicinity of the Fradley Wood Embankment (ref.: FEW) worksite where no works were undertaken.
- Noise and vibration monitoring was undertaken in the vicinity of the A38 Southbound Slip Road Realignment (ref: A38SSRR) worksite where road construction and drainage installation was underway.
- Noise and vibration monitoring was undertaken in the vicinity of the Streethay Cutting Retaining Structure (ref: SCRS) worksite where road construction, road sweeping and deliveries and collections were underway.
- Noise and vibration monitoring was undertaken in the vicinity of the Staffs Lane (ref: SSL) worksite where road construction, road sweeping and deliveries and collections were underway.
- Noise and vibration monitoring was undertaken in the vicinity of the Cappers Lane Compound (ref.: CLC) worksite where no works were undertaken.
- Noise monitoring was undertaken in the vicinity of Whittington Common Cutting (ref: WCC) worksite where stockpiling and material deliveries were underway.
- Noise and vibration monitoring was undertaken in the vicinity of the Tamworth Road Overbridge Satellite (ref.: TROS) worksite where water diversion, and roadhead, site compound and stockpile area operation were underway.
- Noise and vibration monitoring was undertaken in the vicinity of the Swinfen Cutting South (ref: SCS) worksite where haul road extension was underway.
- Noise monitoring was undertaken in the vicinity of the Trunk's Road (ref.: N23)
  worksite where bulk excavations, de-watering system installation, piling and car
  park extension were underway.
- Noise and vibration monitoring was undertaken in the vicinity of the Sutton Road Overbridge (ref.: SRO) worksite where haul road platform access and construction, pond maintenance, topsoil stripping, excavation works, slab and rebar installation, concrete pouring, waste material compaction and materials transportation were underway.

• Noise monitoring was undertaken in the vicinity of the Drayton Lane Cutting (ref.: DLC) worksite where pile cropping, shutter striking, crane operations, steel fixing and concrete pouring were underway.

The HS2 threshold levels for significant noise impacts, which are defined in Information Paper E23 (<a href="https://www.gov.uk/government/publications/hs2-information-papers-environment">https://www.gov.uk/government/publications/hs2-information-papers-environment</a>), were not exceeded during the reporting period.

There were no exceedances of trigger levels as defined in Section 61 consents during the reporting period at any monitoring position.

No complaints were received during the reporting period.

#### 1 Introduction

- 1.1.1 HS2 is required to undertake noise (and vibration) monitoring as necessary to comply with the requirements of the High Speed Rail (London-West Midlands) Environmental Minimum Requirements, including specifically Annex 1: Code of Construction Practice, in addition to any monitoring requirements arising from conditions imposed through consents under Section 61 of the Control of Pollution Act, 1974 or through Undertakings & Assurances given to third parties. Such monitoring May be undertaken for the following purposes:
  - monitoring the impact of construction works;
  - to investigate complaints, incidents and exceedance of trigger levels; or
  - monitoring the effectiveness of noise and vibration control measures.
- 1.1.2 Monitoring data and interpretive reports are to be provided to each relevant local authority on a monthly basis and shall include a summary of the construction activities occurring, the data recorded over the monitoring period, any complaints received, any periods in exceedance of agreed trigger levels, the results of any investigations and any actions taken or mitigation measures implemented. This report provides noise data, and interpretation thereof, for monitoring carried out by HS2 within the Lichfield District Council (LDC) area for the period 1<sup>st</sup> to 31<sup>st</sup> May 2024.
- 1.1.3 Construction sites in the local authority area where monitoring was undertaken during this period include:
  - Shaw Lane Embankment ref: SLE (see Works Identification Plan 1 in Appendix A), where no works were undertaken.
  - Fradley Wood Embankment ref: FEW (see Works Identification Plan 2 in Appendix A), where no works were undertaken.
  - A38 Southbound Slip Road Realignment ref: A38SSRR (see Works Identification Plan 3 in Appendix A), where work activities included:
    - Road construction including slip road installation, excavation and backfilling.
    - o Drainage installation including excavation, and backfilling.
  - Streethay Cutting Retaining Structure ref: SCRS (see Works Identification Plan 3 in Appendix A), where work activities included:
    - Road construction including slip road and drainage installation, excavation and backfilling.
    - o Road sweeping.

- Deliveries and collections.
- South Staffs Lane ref: SSL (see Works Identification Plan 3 in Appendix A), where work activities included:
  - Road construction including slip road and drainage installation, excavation and backfilling.
  - Road sweeping.
  - Deliveries and collections.
- Cappers Lane Compound ref: CLC (see Works Identification Plan 4 in Appendix A), where no works were undertaken.
- Whittington Common Cutting ref: WCC (see Works Identification Plan 4 in Appendix A), where work activities included:
  - o Stockpiling.
  - Material deliveries.
- Tamworth Road Overbridge Satellite ref: TROS (see Works Identification Plan 5 in Appendix A), where work activities included:
  - Water diversion.
  - o Roadhead, site compound and stockpile area operation.
- Swinfen Cutting South ref: SCS (see Works Identification Plan 4 in Appendix A), where work activities included:
  - Haul road extension.
- Trunk's Road ref: N23 (see Works Identification Plan 6 in Appendix A), where work activities included:
  - Bulk excavations.
  - o De-watering system installation including recharge and abstraction wells.
  - Piling including mobilising and drilling for piles.
  - Car park extension.
- Sutton Road Overbridge ref: SRO (see Works Identification Plan 8 in Appendix A), where work activities included:
  - Haul road platform access and construction.
  - Pond maintenance.
  - Topsoil stripping.
  - Excavation works.
  - Slab and rebar installation.
  - Concrete pouring.

- o Waste material compaction.
- Materials transportation.
- Drayton Lane Cutting ref: DLC (see Works Identification Plan 9 in Appendix A), where work activities included:
  - Pile cropping including backfilling.
  - Striking shutters.

  - Steel fixing.
  - Concrete pouring.

# **2** Summary of Results

#### 2.1 Summary of Measured Noise and Vibration Levels

The  $L_{Aeq,T}$  is presented for each of the relevant time periods averaged over the calendar month, along with the highest single period  $L_{Aeq,T}$  that was found to occur within the month.

2.1.3 Appendix C presents graphs of the noise and vibration monitoring data over the month for each of the measurement locations. Noise data presented consists of the hourly L<sub>Aeq</sub> values and, where relevant, the L<sub>Aeq,T</sub> values (where the time period T has been taken to be the averaging period as specified in Table 1 of HS2 Information Paper E23). #### 2.2 Exceedances of the LOAEL and SOAEL

- 2.2.1 The lowest observed adverse effect level (LOAEL) is defined in the Planning Practice Guidance Noise (PPG) as the level above which "noise starts to cause small changes in behaviour and/or attitude, e.g. turning up volume of television; speaking more loudly; where there is no alternative ventilation, having to close windows for some of the time because of the noise. Potential for some reported sleep disturbance. Affects the acoustic character of the area such that there is a perceived change in the quality of life".
- 2.2.2 The significant observed adverse effect level (SOAEL) is defined in the 'Planning Practice Guidance Noise' as the level above which "noise causes a material change in behaviour and/or attitude, e.g. avoiding certain activities during periods of intrusion; where there is no alternative ventilation, having to keep windows closed most of the time because of the noise. Potential for sleep disturbance resulting in difficulty in getting to sleep, premature awakening and difficulty in getting back to sleep. Quality of life diminished due to change in acoustic character of the area."

- 2.2.3 HS2 Phase One Information Paper E23: Control of Construction Noise and Vibration sets out the LOAELs and SOAELs for construction noise.
- 2.2.4 Where reported construction noise levels exceed the LOAEL and SOAEL, relevant periods will be identified. Summary statistics to evaluate ongoing qualification for noise insulation and temporary rehousing are also presented where relevant.
- 2.2.5 Table 5 presents a summary of recorded exceedances of the LOAEL and SOAEL at each measurement location over the reporting period, including the number of exceedances during each time period.
