## Introduction

This Food and Drink Sector Council meeting was focussed on updates on FDSC changes, Workforce Sub-Committee, Food Data Transparency Partnership and the proposed scope of the Resilience Roundtable.

# Updates to the FDSC and next steps

The Council heard an update from Tim Smith on the proposed changes to the FDSC which included reprioritising the focus of the working groups, reducing frequency of meetings, and reducing membership changes to essential appointments only.

Members mostly supported these proposals. In discussion, the following points were raised:

- Members requested three meetings per year and interim updates of the three work streams. This would ensure the meetings allow for strategic discussions and creates tangible outcomes on how to progress work forward.
- Members also suggested a more flexible agenda to allow time to discuss industry concerns and allow for discussion topics to be proposed by members.

#### Workforce Sub-Committee

The Council received a presentation from Sarah Bradbury on the Sector Attractiveness Working Group. Activity includes government and industry collaboration, connecting with careers systems and joint communication plans.

Members supported the work being done within the Workforce Sub-Committee. In discussion, the following points were raised:

- Succession planning should be included in the career resources for businesses, as this is crucial for workforce development.
- Communication tips and tools should be developed to allow business to choose elements that are relevant to them. Access to information is key to ensure businesses can access support.
- Previous areas of sector improvement should be highlighted, such as more flexible working hours, to show how sectors have listened to feedback and adapted practices accordingly to improve working conditions.

 Members were pleased all food supply sectors, including 'out of home' would be included in this work.

## Food Data Transparency Partnership (FDTP)

The Council received updates from Karen Lepper and Natasha Burgon on the Defra led eco workstream and DHSC led health workstream.

Members endorsed and commended both FDTP eco and health workstreams for progress on this complex work. Noting the importance and benefits of reporting should be highlighted and widely communicated to encourage a wide range of companies to engage.

In discussion, the following points were raised:

On the eco workstream:

- Suggestions included an independent data hub for all to use and a data custodian to store the data to ensure data protection and allow all parts of the supply chain to easily access the transferable information.
- Changes to improve the sustainability in primary food production need to be made now to be shown in reported data for 2030, so understanding the climate goals is crucial.

#### On the health workstream:

Members suggested reporting should be mandatory for all sectors, especially SMEs
as they play an important role in the supply chain. Voluntary reporting could lead to
only larger retailers providing data, which would not show the full picture. However,
the limited resource of SMEs could be challenging, and support should be given.

# Resilience Roundtable

The Council received a presentation from Sarah Bradbury on IGD resilience activity, which included 10 long-term risks identified for the UK food system. Nigel Murray presented the proposed scope of the FDSC Resilience Roundtable to gain support from members.

Members broadly supported the scope of the roundtable. In discussion, the following points were raised:

- Members considered the scope of the roundtable looking at the physical aspects of food resilience: availability, safety and quality from climate change, and suggested it may be broadened to include affordability and health of food.
- The focus will be on a commitment in the Third National Adaptation Programme (NAP3) to consider the risks climate change poses to food supply and the appropriate responses.
- Members suggested the roundtable should consider how best to measure food resilience aims to understand what success in this area looks like.
