- 6. I, being the \*owner/ \*agent for the owner of the animals described above, hereby declare that:
- (a) the animals described above were:

#### Either

- \*i. born and have been reared since birth on the territory of the United Kingdom or the European Union; Or
- \*ii. were imported legally from a Third country in accordance with UK rules; AND been resident in Great Britain for at least 6 months;
- (b) The animals described above have been continuously resident on this holding for 30 days prior to entry into quarantine / prior to embryo or oocyte collection;

#### **Health Status of the Holding of Origin**

- (c) the animals described above are not animals which are to be destroyed under an official scheme to eradicate a contagious or infectious disease nor have they been vaccinated against foot and mouth disease;
- (d) the holding from which the animals originate is not under any official restrictions as a result of an outbreak of a notifiable disease, including TB, which affects sheep and goats and none of the animals described above have been in contact with animals from holdings under such restrictions;
- (e) arrangements have been made for the animals to be transported to the approved quarantine/isolation accommodation and/or Semen Collection Centre/holding without coming into contact with any animals other than animals similarly declared and in vehicles/containers which will be cleansed and disinfected with a DEFRA approved disinfectant before use;

#### **Classical Scrapie Requirements:**

  - \*(i) The flock/herd on the holding mentioned at paragraph 3.1 is a member of the Scrapie Monitoring Scheme administered by SAC Consulting, part of Scotland's Rural College (SRUC) and has been listed as \*Controlled Risk, or \*Negligible risk:

\*(ii) In the case of sheep only, the holding is not under any official restrictions due to scrapie and sheep are of the ARR/ARR prion protein genotype, or for collections on or after 1 January 2015, of genotypes that allows a ARR heterozygote embryo to be collected/produced; and

either \*the genotyping was carried out at a \*government laboratory (APHA), or \*SAC/SRUC (where the certificate is issued and it clearly states in the top right hand corner that a veterinarian took the sample and mentions the address);

or \*an official genotyping certificate issued under a National Scrapie Plan scheme

\*Innovis (dated before 31/03/2013) is available.

- 1. To the best of my knowledge and belief, the owner's declarations at Part I paragraph 6(a)-(f) above are a true and correct statement;
- 2. The donor animals are individually identified in compliance with the requirements of Regulation (EU) 2020/692;
- 3. I have certificate ET100/ET101 Disease clearance from the Centre for International Trade in Carlisle, authorising me to certify that the following diseases have not been confirmed on the holding of origin mentioned at Part I paragraph 3.1 during the periods stated prior to movement into / start of quarantine or prior to the collection of oocytes / embryos:

Scrapie: during the past 3 years

Foot and Mouth Disease for the past 3 months on the holding of origin Foot and Mouth disease not recorded in an area of 10km radius around the holding of origin during the past 30 days

\*Contagious epididymitis of rams (*Brucella ovis*): during the past 12 months Brucellosis (*Brucella abortus, B.melitensis, B.suis*): during the past 3 months

Rabies: during the past 30 days

Anthrax: during the past 30 days

Tuberculosis: during the past 42 days, including any TB related restrictions Surra (*Trypanosoma evansi*) for the last 2 years

\*Glanders (*Burkholderia mallei*) for the last 6 months (requirement for caprine animals only)

\*(a) I have seen the owner's Certificate of Registration to the SAC Scrapie Monitoring Scheme and can confirm that the flock/herd is listed as \*Controlled Risk, or \*Negligible risk;

- \*(b) I have seen documentary evidence a laboratory report from a \*government laboratory (APHA) / \*a laboratory authorised by the government (SAC/SRUC) or \*an official genotyping certificate issued under a National Scrapie Plan scheme (e.g. the Compulsory Scrapie Flocks Scheme, Ram/Ewe Genotyping Scheme) confirming the genotype of the individual sheep identified on this certificate as ARR/ARR or for collections on or after 1 January 2015, of genotypes that allows a ARR heterozygote embryo to be collected/produced;

The quarantine/isolation accommodation at Part I paragraph 3.2 has been officially approved in accordance with official guidance.

7. I have certificate ET100/101 from the Centre for International Trade - Carlisle, authorising me to certify the following:

The quarantine / isolation accommodation and semen collection centre (donor males) / the holding of origin (donor females):

- (i) it is situated in an area in which there has been no outbreak of Foot and Mouth Disease for the past 30 days within a 10 kilometre radius;
- (ii) it has for the past three months been free from foot-and-mouth disease and
- (iii) it has for the past 30 days been free from the following compulsory notifiable diseases:
  - Brucellosis (B.abortus, B.melitensis, B.suis), Tuberculosis, Surra, Epizootic Haemorrhagic Disease, Bluetongue, Rabies and Anthrax, and ovine epididymitis (Brucella ovis) has not been reported;
- It is not situated in a restricted zone due to Rinderpest, Foot and Mouth (iv) Disease, Rift Valley Fever, Peste des Petits Ruminants, Sheep or Goat Pox and Contagious Caprine Pleuropneumonia.
