NOTES FOR GUIDANCE FOR EXPORTERS AND OFFICIAL VETERINARIANS - 7006NFG

IMPORTANT

Exporters and Official Veterinarians (OVs) are advised that the conditions for export of pig meat to the People's Republic of China (PRC) are complex and demanding. Clearances for certain non-notifiable diseases such as PRRS on premises of origin are not straight forward and special procedures have been introduced to facilitate these declarations.

Well in advance of exports taking place, exporters and certifying OVs must become familiar with these notes for guidance and all associated documents. 7006NFG - PART 5: FINAL CERTIFICATION AT EXPORTING COLD STORES

1. INTRODUCTION

These notes are intended for exporters and certifying OVs in a PRCapproved cold store from where the consignment will be dispatched to its final destination in the PRC. They must be read in conjunction with 7006NFG Part 1: Introduction and General Principles; and the 7006EXA: Guidance document on completion of the interactive precertificate (application for export/EHC to CSC Carlisle or DAERA).

Certifying OVs in cutting plants are required to provide support documentation in the form of an Internal Movement Certificate (IMC), confirming that the consignment of meat meets PRC requirements in full. This support document enables the OV in the premises of despatch to sign final export health certificate 7006EHC.

2. ADVANCE PROVISION OF SPECIMEN COPIES OF OV SIGNATURES AND STAMPS

The PRC requires that all OVs carrying out export certification must first provide specimen copies of their signatures and stamps to China before exports take place. Signatures must be linked to the cold store of despatch. Specimen copies of stamps and signatures of alternative OVs should also be provided to allow for absences such as sickness and holidays. However, at present PRC will only permit a maximum of three (3) OVs per cold store at any one time.

If additions or modifications are required, OVs should submit the details on the form at ${\bf Annex}\ {\bf 1}$ to these notes. The form should be scanned and sent by e-mail to the APHA CSC Carlisle for plants in GB and to DAERA for plants in NI for onward transmission to the PRC. Updates to the list will be sent to China at intervals of 6 months and, on each occasion, several weeks should be allowed for the information to be processed by the authorities in China and forwarded to ports. Additional ad hoc requests may also be accepted, but this cannot be guaranteed. Exporters should therefore plan ahead and ensure any likely changes or additions to their OVs details are communicated well in advance. Consignments may be at risk if exports commence before the authorities in the PRC have received and confirmed that the updated specimen signatures and stamps can be used. Defra will inform APHA/DAERA of the effective date of implementation of the updated versions of the table with OV specimen signatures and stamps.

Please see further guidance on entering the OV name, stamp and signature in the final certificate at Section 6 (Notes on completion of 7006EHC) below.

3. SCOPE OF EXPORTS TO THE PRC

Please refer to Part 1 of 7006NFG.

USE OF INTERNAL MOVEMENT CERTIFICATES (IMCs) FOR MOVEMENTS BETWEEN PREMISES OF PRC EXPORT ELIGIBLE MEAT:

The OV at the supplying cutting plant must complete a copy of an Internal Movement Certificate (IMC) for downstream movement of each consignment of meat intended for export to the PRC (form 7006IMC or similar document). The OV at the cutting plant must give each IMC a unique reference number which should consist of the plant approval number followed by the date of slaughter and a sequential number e.g.: UK1234EC/21.03.19/05 or 1234/21.03.19/05 from 1 November 2020.

(See 7006EXA and guidance document and Section 5 below of this document for more information on new approval/registration number format with effect from 1 November 2020.

The paper copy of the 7006IMC can be handwritten - information does not have to be typed but the details must be clearly legible and unambiguous.

The OV at the cold store must retain all copies of IMCs received from supplying premises for a period of at least one year after the date of export.

5. APPROVAL OF MEAT PLANTS AND COLD STORES TO EXPORT TO THE PRC

All slaughterhouses, cutting premises, manufacturing premises and cold stores intending to export eligible pork and pig meat products to PRC require specific inspection and approval prior to export taking place.

Please refer to Part 1 of 7006NFG for full details on procedures for premises approvals AND the 7006EXA guidance document for approval/registration format with effect from 1 November 2020.

A list of premises specifically approved for export to the PRC is included in Annex 2 of this document and at the UKECP website. The list will be updated as required. The list is also available on GACCs website https://ciferquery.singlewindow.cn/

The establishments present in the supply chain for exporting pork and pig products to PRC must be eligible, at the time of certification, to export to PRC and be linked in the associations list included in annex 3.

*** IMPORTANT *** REFERENCES TO APPROVAL NUMBERS FROM 1 NOVEMBER 2020

The UK has reached an agreement with the General Administration of Customs of the People's Republic of China (GACC) to update the details of the approval numbers of all UK establishments requiring listing with China. With effect from 1 November 2020 the approval/registration numbers for establishments listed to export pork to China will cease to have references to UK and EC. From that time, approval/registration numbers will include the central unique identifier number ONLY [four numerical digits for abattoirs (under ${\tt FSA/FSS/DAERA\ control)\ -\ or\ -\ five/six\ alpha-numerical\ digits\ for}$ cold stores (where under local authority approval)].

The format of the approval/registration number including the UK affix and the EC suffix shall continue to be used and entered in Sections

II (a), (b) and (c) of 7006EHC export health certificates signed before and up to 31 October 2020.

The format of the approval/registration number without the UK affix and the EC suffix shall be used and entered in Sections II (a), (b) and (c) of 7006EHC export health certificates signed after 31 October 2020.

Illustrative examples:

Format to be used in export health certificates SIGNED BEFORE 1 November 2020	Format to be used in export health certificates SIGNED AFTER 31 October 2020
UK 2090 EC	2090
UK AB123 EC	AB123

Consignments certified before 1 November 2020 (which must contain UK and EC references in the approval/registration number) will be accepted for import to China upon arrival within a crossover period of 2 months after 31 October 2020.

THE NEW FORMAT APPLICABLE FROM 1 NOVEMBER 2020 MUST BE USED IN ALL DOCUMENTS ASSOCIATED WITH EXPORTS OF PORK TO CHINA, INCLUDING IN INTERNAL MOVEMENT CERTIFICATES SIGNED FROM THAT DATE (7006IMC -Section II refers).

The PRC authorities will expect that the details of the establishments entered onto the certificate are both correct, consistent and in accordance with their own records of approved establishments. Approval numbers, and other details, should exactly match the details as listed on the GACC website:

The new listing by GACC replaces the previous listings by CNCA and does not contain the name and addresses of the establishments.

These can still be checked by exporters and OVs at Annex 2 of this quidance document.

Health/ID marking of products: GACC will accept consignments of product bearing either the current format of oval health/ID marks (with UK and EC) or any other acceptable format prescribed by the UK authorities following the UK's exit from the EU. Some consignments might contain a mix of products which each might bear different health/ID marks (see advice at the 7006EXA guidance document on completion of section III (1) of the 7006EHC on "Shipping marks"). Products will be identified as originating from the final establishment of production by cross-reference with the central unique identifier number of the establishment in the oval mark/stamp of the product.

Export of Trotters to the PRC

Exporters and OVs are reminded that additional premises approval is required for the export of trotters to the PRC. Under no circumstances can export of trotters take place from premises that are not so approved. Operators of approved premises are required to meet the conditions laid down in the document entitled 'Standard Operating Procedures for the export of trotters to the People's Republic of China', which is included as an Annex in 7006NFG - Part 1.

When completing final export certification for trotters, OVs at the cold store <u>must</u> carry out the necessary checks to ensure that the premises where the trotters intended for export were processed and packaged is listed as approved for export of trotters to the PRC.

Only those premises indicated as such in Annex 2 of this document are approved for the export of trotters.

NOTES ON COMPLETION OF 7006EHC 6.

Certifying OVs at export cold stores must note that unauthorised deletions or manuscript amendments to 7006EHC are not permitted. The only permitted handwritten entry is the signature of the OV. The date of certification must be entered using an inked rubber stamp. The OV signature and the date stamp must be made ink of any colour other than black.

The details of the OV must exactly match the information supplied in the completed Annex 1 for the specimen OV stamp and signature. This also includes the Official Veterinarian name. Entering additional information, e.g. title or qualifications/registrations (including $\mathrm{M/F}$ RCVS) of the OV alongside the name in the 7006EHC certificate is not acceptable. Any certificates containing details/information of the OV at the signature section not matching those/that of the completed template supplied by the OV to APHA or DAERA for submission to P.R. China will likely result in consignments being detained on arrival to China.

OVs and exporters should note that they have the final responsibility to ensure that the details on the completed certificates are correct. Due to the complexity of the conditions, it is recommended that such checks should be carried out sufficiently in advance of the date of export to enable any changes that may be required. The PRC authorities will expect that the details of the establishments entered onto the certificate are correct and consistent.

OFFICIAL VETERINARY DECLARATION - CERTIFYING COMPLIANCE WITH THE 7. PROTOCOL

Part V of 7006EHC refers. Please refer to Part 1 of 7006NFG for a description of The Protocol and the relevant Articles. For the purposes of certification of exports of pig meat, Articles 4 - 10

Articles 1 and 2 and Articles 11 - 16 may be certified by the OV on the basis of information already supplied to AQSIQ (now GACC) by the UK competent authorities, together with operating and administrative procedures described in these Articles as agreed between Defra and AQSIQ (now GACC).

Article 3 - Official Disease Clearances

Article 3 of The Protocol may be certified on behalf of the Department provided written authority to do so has been obtained on form 618NDC from the APHA Customer Service Centre (CSC) at Carlisle or the issuing office of DAERA in Northern Ireland.

Articles 4(a), 4(b) and 4(c) - UK origin of the animals and premises of origin freedom from specified diseases

The above conditions may be certified on the basis of IMCs signed by the official veterinarian at the supplying slaughterhouse/cutting plant confirming that the consignment complies with the import conditions of the PRC.

Article 5 - approval of premises exporting to the PRC

All establishments in the export supply chain must hold prior approval to export to the PRC. This may be certified on the basis of IMCs signed by the official veterinarian at the supplying slaughterhouse/cutting plant. All establishments in the supply chain must also be linked via the associations list as included in annex 3.

Article 6 - compliance with UK Hygiene Regulations / fitness for human consumption

The EU legislation mentioned in this document and that the UK is complying with will be incorporated into our UK law as "retained EU law" under the European Union (Withdrawal) Act 2018 upon the UK exit from the EU. References and compliance with the EU law and the correspondent UK law enacted under the Withdrawal Act should be deemed as equivalent.

Paragraphs (a), (b), (c) and (e) of Article 6 may be certified on the basis of the oval mark and evidence that the slaughterhouse, cutting plant, meat products plant (if applicable) and cold store are officially approved by Local Authorities and operating in accordance with Regulations (EC) Nos. 852/2004, 853/2004 and 854/2004 and, in the case of microbiological criteria, Commission Regulation (EC) No. 2073/2005.

With regard to residue levels, paragraph (c) of Article 6 may be certified on the basis of the results of the national surveillance scheme for residues, to which all approved meat establishments are subjected. In the UK, the national surveillance scheme implements Council Directives 96/22/EC and 96/23/EC. The HACCP requirements in Regulation (EC) 852/2004 (Article 5) also places an obligation on all approved meat establishments to ensure compliance with these Directives.

The above Directives are transposed into national legislation by The Animals and Animal Products (Examination for Residues and Maximum Residue Limits) (England and Scotland) Regulations 2015 and parallel legislation in the devolved administrations of Wales and Northern Ireland.

For the purposes of this certificate OVs should note that residue limits as stipulated by the UK competent authorities and AQSIQ (now GACC) are regarded as equivalent.

Article 7 - segregation of slaughter for non-eligible animals and provision of a dedicated area for storage

The requirement for segregation pre- and post-slaughter and during preliminary processing may be certified on the basis of IMCs signed by the official veterinarian at the supplying slaughterhouse/cutting plants confirming that the consignment complies with the import conditions of the PRC.

All PRC export-eligible meat must be processed, wrapped and packaged separately from other meat not eligible for export to the PRC.

In order to ensure PRC's requirements for traceability and segregation, meat eligible for export to PRC must be clearly identified throughout the entire export chain.

The certifying OV at the exporting cold store must be fully familiar with the Standard Operating Procedures (SOPs) for segregation/separation. These written procedures must explain how this requirement is achieved and maintained in the cold store from the intake of meat to despatch.

Articles 8 and 9 - wrapping, packaging and storage of exported goods

Please refer to the relevant Articles of the Protocol for a description of labelling, packaging and storage details.

8. ELECTRONIC PRE-CERTIFICATION

The Official Veterinarians (OV) providing final certification for consignments to PRC are required to submit a weekly notification which should include all relevant data for any certificate signed by the OV for the previous week.

In GB, the OV must submit the electronic table to processingteam@apha.gov.uk before 12pm each Monday.

In Northern Ireland, the OV must submit the electronic table to the vs.implementation@daera-ni.gov.uk mailbox before 11am each Monday. Data entry must be accurate, in the agreed format and match the consignment details otherwise acceptance from the Chinese authorities may not be granted. The OV is responsible for ensuring that all data submitted is correct and APHA cannot be held responsible if a consignment is held or delayed if inaccurate data has been provided. APHA send all notification tables to the CIO for their approval. A template copy of the weekly notification table can be supplied by contacting processingteam@apha.gov.uk.

AMENDMENTS TO NOTIFICATIONS

On occasion it may be required to amend the details on a notification for changes that occur when the consignment is in transit, e.g. a change in consignee. When a change is required the certifying OV must submit a table using the same template as the initial notification, only to include the row pertaining to the consignment which has changed. Each column should be completed to give full information of the consignment, and the details which differ from the original notification must be highlighted by having the font in red text.

The notification of amendments should be sent by the OV on an ad hoc basis as and when required, to the same email address as per the weekly notification. APHA will forward the details to CIQ for their approval. CIQ will reference the original notification and make alterations based on the amended details shown by red text.

9. DISCLAIMER

These notes are provided on the basis of information available at the time. It is the exporter's responsibility to check the information against any relevant import permit or any advice provided by the competent authority in the importing country.
