# Representations received

- Four received about the project; 'To discuss Moulsham Junior School (single-academy trust), Moulsham Infant School (single-academy trust), Writtle Junior School (local authority maintained), Writtle Infant School (local authority maintained) and Highwood Primary School (local authority maintained), Essex, forming the HIVE Family of Schools (multi-academy trust), Essex.'
