JUDGMENT

- 1. The claimant's application for a reconsideration of the Judgment promulgated on 27 March 2024 and in respect of which written reasons were promulgated on 10 May 2024, is refused. It is not in the interests of justice for there to be a reconsideration.
- 2. The claimant's application for an Oder that she be released from any obligations imposed by Rule 31.22 of the Civil Procedure Rules is dismissed.
- 3. The claimant's application for the revocation of the Order made pursuant to Rule 50 of the Employment Tribunals (Constitution and Rules of Procedure) Regulations 2013 is dismissed, but it is hereby recorded that nothing in this Order shall prohibit the claimant from exercising her right to make protected disclosures to the regulatory authorities in the UK, Europe, the United States or globally (including, for the avoidance of doubt, the NHS and the FDA) and/or to the Police or Law Enforcement Agencies in those jurisdictions, as set out and summarised in the respondent's solicitor's letter to the claimant dated 1 March 2024.

4. By not later than **22 July 2024** the claimant shall inform the Employment Tribunal Regional Office in Newcastle-upon-Tyne as to whether she still requires written reasons for the making of the Rule 50 Order to be sent to the Employment Appeal Tribunal, or whether she intends to withdraw her appeal to the Employment Appeal Tribunal in respect of a making of the original Rule 50 Order.
