The Bluetongue Regulations 2008 (as amended) - regulation 13, 14 & 28

The Movement of Animals (Restrictions) (England) Order 2002 (as amended) - article 5A

Declaration of a Restricted Zone and an Infected Area In Norfolk and Suffolk

- 1) Upon the Chief Veterinary Officer having reviewed evidence that there is some local transmission of bluetongue virus in England and confirming that the bluetongue virus is therefore circulating in England, the Secretary of State hereby declares the area identified in Annex 1 to be a restricted zone in accordance with regulation 13(1)(a) of the Bluetongue Regulations 2008 (as amended).
- 2) In addition, the Secretary of State hereby declares the area identified in Annex 1 to be an infected area in accordance with article 5A of the Movement of Animals (Restrictions) (England) Order 2002 (as amended) hereafter referred to as a Restricted Zone.
- 3) The restricted zone and infected area are comprised of the area identified in Annex 1.
- 4) The measures set out in Annex 2 shall apply in the restricted zone.
- 5) As regards the infected area:
 - a. The disease in respect of which the infected area is being declared is Bluetongue.
 - b. The animals to which the declaration relates are all species of Ruminants and Camelids.
 - c. In order to prevent the spread of disease, the Secretary of State considers additional measures necessary. These measures are specified in Annex 3 and apply in the infected area.
- 6) These measures apply from 20.00 on 30 August 2024 until this Declaration is revoked or amended by further declaration.
- 7) The temporary control zone declared at 18.30 on 28 August 2024 is hereby revoked from 20.00 on 30 August 2024.
- 8) General Licences EXD601 (BTV) (E), EXD602 (BTV) (E), EXD610 (BTV) (E) and EXD611 (BTV) (E) dated August 2024 all hereby revoked and withdrawn from 20.00 on 30 August 2024.

Any person who contravenes a provision of this Declaration made under the Bluetongue Regulations 2008 (as amended) shall commit an offence and is liable on summary conviction to a fine not exceeding level 5 on the standard scale or to imprisonment not exceeding 3 months or to both. A summary conviction may be up to 6 months imprisonment where an offence is committed under the Movement of Animals (Restrictions) (England) Order 2002 (as amended).

Annex 1 – Restricted Zone and Infected Area

The below area comprises those parts of England contained within the red circle and consists of the counties of Norfolk and Suffolk.

For illustrative purposes, the restricted zone and infected area is indicated in the map below.



Annex 2 – Measures that apply in the Restricted Zone under the Bluetongue Regulations 2008 (as amended)

1. No person may move an animal, or germinal product out of a restricted zone except under the authority of a licence granted by a veterinary inspector or by an inspector or officer of the Secretary of State acting under the direction of a veterinary inspector (regulation 13 (2) of the Bluetongue Regulations 2008 (as amended)).
2. A person is prohibited from moving an animal within a restricted zone if the animal shows clinical signs of bluetongue on the day of transport. (regulation 13 (5)).
3. If an animal is transported from a restricted zone to a slaughterhouse outside that restricted zone in accordance with a licence, the operator of the slaughterhouse must slaughter the animal within 24 hours of arrival (regulation 14 (2)).
4. Pursuant to regulation 28(a), and by way of licence derogating from the requirement at point 1 above, dairy cattle may be moved from the restricted zone to their usual milking parlour and returned directly to the place of origin. The movement shall be by foot to and from the regular place of milking used for the relevant herd.

Annex 3 – Measures that apply in the Infected Area under the Movement of Animals (Restrictions) (England) Order 2002(as amended)

1. No person shall move an animal belonging to a species to which this declaration relates, into or out of the area declared to be an infected area, except under the authority of a licence issued by a veterinary inspector or an inspector under the direction of a veterinary inspector (article 5A(4))
2. No person shall move an animal to or from premises within the area declared to be an infected area, except under the authority of a licence issued by a veterinary inspector or an inspector acting under the instructions of a veterinary inspector (article 5A(5))
3. Where an animal is transiting the area declared to be an infected area, the animal must be moved in a vehicle and by the shortest available route without being unloaded (article 5A(7))
4. Pursuant to regulation 5A(3)(e), and by way of licence derogating from the requirement at point 3 above, dairy cattle may be moved from the infected area to their usual milking parlour (in the free area) and returned directly to the place of origin. The movement shall be by foot to and from the regular place of milking used for this herd.
5. No person shall collect, process, handle or store any germinal product in the infected area unless they do so on premises designated under regulation 14A of the Bluetongue Regulations 2008 (as amended) or under the authority of a licence granted by the Secretary of State.

6. No person shall freeze any germinal product located in the infected area unless the germinal product is frozen on premises designated under regulation 14A of the Bluetongue Regulations 2008 (as amended) or otherwise in accordance with the terms of a licence issued by the Secretary of State.
7. Auditable and accurate records of collection, storage, use and disposal, must be prepared and maintained until such time that the donor animals BTV free health is confirmed by testing and to evidence compliance with licence conditions for any subsequent movement.

Notes:

1. In this Declaration:
 - a. “animal” means a ruminating animal or a camelid;
 - b. “germinal product” means the embryo, ovum or semen of an animal.
2. Premises partly inside the restricted zone and partly inside the free area are treated as being inside the restricted zone (Bluetongue Regulations 2008 (as amended), regulation 7 (4)(b)).
3. Premises partly inside a restricted zone and partly inside a temporary Control zone or Control Zone are treated as being inside the temporary control zone or Control Zone (Bluetongue Regulations 2008 (as amended), regulation 7 (4)(c)).
4. Premises partly inside and partly outside an infected area are deemed to be wholly within that infected area (Movement of Animals (Restrictions) (England) Order 2002 (as amended), regulation 5A (6))
