GV72: Transfer of Operating Centres: SCHEDULE 4

Supplementary Application Form

About this form

You should complete this form if you wish to apply to transfer operating centres. Schedule 4 to the Goods Vehicle (Licensing of Operators) Act 1995 provides a simplified procedure for the transfer of an operating centre(s) from one operator's licence to the licence of another operator or potential operator.

It can be used at the time of your application for a new licence or at the time of an application to vary an existing licence.

Where this procedure is used no advertisement is required in connection with your application. There are no separate fees charged for an application to use the provisions of Schedule 4. However, the accompanying GV79 (for a new application) or GV81 (to vary an existing licence) will usually attract a fee. In the case of GV79s there will always be an application fee. Whether a GV81 attracts a fee depends on the circumstances of the application. If the authorisation on the applicants licence is sufficient to absorb the authorisation to be transferred and the applicant does not wish to increase the overall authority on their licence then no fee is payable. In all other circumstances an application fee is payable. That will also be the case if the request for Schedule 4 is declined and an advertisement is deemed necessary by the traffic commissioner.

The operating centre(s) being transferred must be specified on a licence (but not more than one) on the date the application is made, and it will be removed from that licence if the application is granted.

Any conditions that apply to the operating centre(s) concerned are transferred with it, and any undertakings must be accepted by the new operator. Conditions and undertakings cannot be amended at the time of transfer.

Use of the schedule 4 transfer procedure is at the discretion of the traffic commissioner. If the grant of a schedule 4 application would extend the review period for the operating centre(s) concerned then the traffic commissioner must be satisfied before a decision is made that no new adverse effects or environmental conditions would be likely to arise as a result.

Filling in the form

Use black ink to fill in the form. This form should be completed in full and submitted with a GV79 form (in the case of a new licence application) or a GV81 form (in the case of an application to vary a licence) completed by the applicant.

Section A of this form must be completed by the applicant and Section B must be completed by the operator or person who is giving up the operating centre.
